Tender / bidding documents may be obtained during office hours from 0830 to 1630 hrs from store office ASF Islamabad airport at the cost of **Rs. 1,000/- cash (non-refundable)** with written request on firms/bidder's letter head, failing of which said firm/bidder proposal shall not be entertained.
5. Tender will be opened in store office ASF Islamabad Airport at date and time mentioned against each tender in the presence of bidders / bidder's rep.
6. All bidders must accompany by **earnest money in shape of pay order @ 3%** of the total bid value **(Refundable)** in favour of CSO ASF Islamabad Airport and uploaded the same on E-PADS as part of technical proposal.
7. Incomplete, ambiguous and conditional tenders will not be accepted
8. Tender will be opened on next working day if the date of opening is declared as holiday.
9. Any financial/technical instrument submitted by bidder, if found bogus/fake at any stage would result in blacklisting and legal action as per law/PPRA Rules 2004.
