



## **TENDER NOTICE**

Pakistan Bait-ul-Mal (PBM), an organization of Federal Government was established under PBM Act 1991 to provide financial assistance to destitute and needy widows, orphans, invalid, infirm and such other persons, and thereby save them from hardships, sufferings and enable them to lead an honorable life in the society. It is premier Public Sector social safety net in the country and has mandate to serve the marginalized segment of the society through its various pro-poor Programmes.

2. PBM established Shelter Homes, a welfare Programme to provide valued but temporary overnight stay with two-time meals (free of cost) to the needy individual seeking bed and breakfast across the country. Further, Khana Sab Key Liye Programme (Food Vehicles) are also operative in various cities for distribution of pre-packed cooked meals to target population, which mainly requires food, at their nearest point.

3. PBM intends to carry out impact evaluation of these two (2) Projects i.e. Shelter Homes and Khana Sab Key Liye (KSKL) Programs to assess the overall impact / effectiveness of the programs and invites e-bids for hiring of services of a firm/ organization (FBR Income Tax & Sales Tax registered active) on single stage two envelope basis.

4. Bidding documents, containing specification, detailed terms and conditions, procedure for submission of bids, method of impact evaluation, bids security, bid validity, guarantee, acceptance and rejection of bids etc. are available at PPRA EPADS for registered bidders.

5. **Pre-bid meeting will be held on 20-01-2026 at 1100 hrs** at PBM Head Office, H-8/4, Islamabad. All interested bidders are encouraged to attend.

6. Encrypted Electronic Bids (both Technical and Financial) in accordance with PPRA rules and instructions given in the Standard Procurement Documents, shall be submitted at E-Pak Acquisition & Disposal System ([www.eprocure.gov.pk](http://www.eprocure.gov.pk)), accompanied by call deposit receipt( s) / pay order(s) / Bank draft(s) as earnest money (refundable/ interest free), amounting to Rs. 180,000/- in favour of Pakistan Bait ul Mal, **on or before 29<sup>th</sup> January, 2026 till 11:00 hrs.**

7. Technical bids will be opened on the same day (29<sup>th</sup> January, 2026) at 11:30 hrs in Pakistan Bait ul Mal, Head Office, H-8/4, Islamabad in the presence of bidders or their authorized representatives. Whereas, Financial Bids of Responsive Bidders will be opened later on for which date and time will be communicated through EPADS.
