Terms & Conditions

- 1) The E-Bidding documents as per regulation containing detailed terms and conditions, specifications and requirements etc. are available for the registered bidders at K.P. WWB Website: www.gov.pk & EPAD.
- 2) All electronic bids must be accompanied by a bid security, stamp duty and tender form fee in the form of either call deposit / demand draft / payment order as per amount mentioned against each work in favor of Secretary Khyber Pakhtunkhwa Workers Welfare Board, Peshawar. The prospective bidders shall upload a scan copy of the bid security etc. on EPADS. Original bid security etc. must be submitted to the procuring agency on or before the closing time on bid submission, failing which the bid shall be rejected.
- 3) Bid security of the 1st, 2nd and 3rd lowest electronic bidder for the specific work will be retained by the Department till the approval of bid.
- 4) Electronics bids must be submitted through EPADS on or before the bid closing date and time as specified above. Manual bid will not be accepted. Electronic bids will be opened by using EPADS publicly on the same day on 02-02-2026 in the committee room of KP WWB Main Office Building located at phase -V, Hayatabad, Peshawar.
- 5) Cutting and overwriting in the bid documents shall not be accepted.
- 6) The prospective bidders are also required to submit an undertaking on stamp paper duly attested by notary public worth not less than Rs.100/-, that the firm/ contractor are neither involved in any litigation nor blacklisted by any government or semi government or autonomous body in Pakistan and also under takes that if any information or documents provided by firm for issuance of tender documents is found in correct, the firm is liable for disqualification and legal action under the law.
- 7) The rate may be offered as %age above or %age below or At Par on estimated cost.
- 8) The Contractors quoting their bids more than 10% below up to 20% below on estimated cost shall submit along with their bids 8% additional security of the estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security then it will be considered as a non-responsive bid and the 2% bid security shall be forfeited in favor of Government and the 2nd lowest bidder and so on will be considered accordingly.
- 9) In case of more than 20 % below rates, a detailed rate analysis must be submitted along with valid and justifiable supporting documentation.
- 10) The contractor or his representative may be present at a time of opening of electronic bid.
- 11) In case of tie/ draw amongst the responsive bidders the bid may be decided through free toss which shall be considered as final.
- 12) The Khyber Pakhtunkhwa Workers Welfare Board reserves the right to accept or reject any or all bids, in accordance with the provision of PPRA Rule No.33(1)
