2. The National Highways & Motorway Police invites sealed bids from eligible firms/Suppliers for the supply of abovementioned items.
3. **Single Stage Two Envelop Bidding Procedure** of Principal Method of Procurement (i.e. Open Competitive Bidding) will be used by adopting **Least Cost Based Selection (LCBS) Technique** for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time).
4. All Proposals must be accompanied by a Bid Security also mentioned in the Bidding Document.
5. The Bids will be received only from those firms who are registered with PPRA for e-procurement on EPADS for Tendering through their Email address which were provided by them to PPRA at the time of their registration.
6. In case opening date(s) is declared as a Public Holiday by the Government, the next working date shall be deemed to be the date for submission and opening of tender(s) at the same time and place.

The original bid (as prescribed in Bid Data Sheet of the Bidding Document) in accordance with the provisions of Rule 36(b) of Public Procurement Rules, 2004 and terms and condition defined in the bidding document must be submitted through EPADS and in hard form delivered at the address mentioned below **on or before 01:00 PM 28/01/2026**. Only those bids shall be entertained which are submitted through EPADS.
