National Grid Company of Pakistan (NGCP) (formerly known as NTDC) is a corporatized company/entity under the Ministry of Energy (Power Division), Government of Pakistan, responsible for operation and maintenance (O&M) of high voltage transmission network i.e. 500 kV and 220 kV grid stations and transmission lines throughout Pakistan. NGCP invites sealed bids for the procurement of Personal Protective Equipment (PPE) for its HVDC formations located at Hyderabad, on the basis of National Competitive Bidding (NCB) by adopting Single Stage Two Envelope Bidding (SSTE) procedure, from the eligible bidders meeting the following mentioned eligibility criteria.

It will be Contractor's / Supplier's liability to Transport Material to the office of Manager (O&M) HVDC NGC, Hyderabad Bungalow No: 477, Block A, Gulshan-e-Zeal Pak Cooperative Housing Society, Hyderabad & Executive Engineer (O&M) HVDC NGC 220KV Grid Station NGC Sangrar Link Road Rohri. All Transport Charges will be borne by the Contractor / Supplier.
