

authenticate their complete E-Bids (by uploading PDF file) and it must be submitted online on e-procurement system (EPADS) website i.e. <https://eprocure.gov.pk>.

4. The prospective bidders are required to submit Bids Security / Earnest Money (CDR) amounting to as above mentioned against work in favour of Cantonment Board Officer, Cantonment Board Gujranwala, CDR must be issued from any schedule bank against firm's account. Name of firm should be clearly mentioned on instrument (Call deposit / CDR). The Prospective bidders shall be submitted three (03 days) before opening of Bids & Pay order is not acceptable.
5. The Prospective bidders shall upload scanned copy of undertaking on original judicial stamp paper worth Rs. 1200/- that their firms are not involved in any litigation.
