2. The contractors are required to submit their application for issuance of tender documents alongwith their complete credentials as shown at (Serial-09) by **30th January 2026**. The applications shall be scrutinized and the tender documents will only be issued to the firms who have sufficient experience in the relevant field and satisfy other special conditions required for the job and area. Tenders will only be issued to the scrutinized contractors.

3. The tender must be received in the office of accepting officer by **1130 hours on 07th February 2026** and will be opened at 1200 Hrs on the same date.

4. All contractors, irrespective of their enlistment or non-enlistment with MES will certify in writing that they are registered with Pakistan Engineering Council (PEC), and will submit a copy of their registration. Contractors not registered with PEC are ineligible to apply.

5. Contractors borne on the approved List of MES in category 'A', 'B', 'C' & 'D' having experience of this type of work may only apply.

6. Contractors who desire may be present at the time of opening of tenders.

7. The accepting officer reserves the right to accept or reject the tender. Rejected tenders will be dealt with as per Para 33 (i) of PPRA Rules
