WATER AND POWER DEVELOPMENT AUTHORITY through Executive Engineer AC Plant Division, 311- WAPDA House, Lahore, invites electronic bids from the original manufacturers/authorized distributors/suppliers/contractors/service providers, registered with income tax and sale tax department and on Active Tax Payer list (ATL) of FBR for "**DISMANTLING, SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF 02 No. NEW AHU'S i.e. GROUND FLOOR 'F' AND 1ST FLOOR 'H', (COMPLETE UNIT REPLACEMENT) AND FRESH AIR DUCT LINE (TREATED AND UNTREATED) WITH INSULATION ON TURNKEY BASIS**" Time period for completion of Contract is

**a)** Dismantling, Supply, Installation, Testing and Commissioning of 2 No. New AHU's on turnkey basis

i. Cooling Capacity : 16 RT

ii. Air Flow Rate : 6400 CFM

iii. Induction Motor (3 Phase, 50 Hz, 1480 RPM) : 5 kW

**b)** Dismantling, Supply and Installation of Treated and Untreated Fresh Air Duct Line with Insulation (3400 sq. ft.) on turnkey basis.
