## **Notice Inviting E-Bidding Single Stage One** **Envelope Trough E-PADS**

Cantonment Board Wah intends to procure medicines for its CB Dispensaries and hereby invites E-Bids from reputable, registered, and eligible firms to submit sealed quotations for the supply of prescribed medicines on the basis of maximum discount on retail prices. The bidders must be holding valid National Tax Number (NTN) and Sales Tax Registration Number (STRN) certificates and shall fulfill all prescribed eligibility criteria as laid down in the bidding documents.

2. Each tender shall be submitted in a separate sealed envelope, clearly marked with the name of the item/tender on the outside.

**CONDITIONS:** - The general conditions in this regard will be as under.

1. Bidding documents are available on PPRA, E-PADS portal only. No hard copy will be issued.
2. Only those contractors / chemists who are registered with PPRA on E-PADS as vendors shall be eligible to participate through online E-PADS tendering. The bidders shall complete and authenticate their complete e-bids by uploading the required PDF files before the bid opening date. The bids must be submitted online on the e-procurement system (E-PADS) website, i.e., <https://eprocure.gov.pk>, in accordance with Rule 36(a) of PPRA Rules, 2004, and the terms and conditions of the bidding documents.
3. The mode of procurement will be single Stage One Envelop and the bids will be evaluated in accordance with laid down evaluation criteria as per PPRA rules and according to advertisement terms & conditions.
4. The cut off time for submission of online bids will be 1200 hrs dated **02/02/2025** and shall be opened on same day at 1400 hrs electronically in the office of the Cantonment Board, Wah, in the presence of the participating firms or their authorized representatives who may wish to attend.
5. Contract will be for one year starting from 01/02/2026 to 31/01/2027 and can be extended till the new contract is finalized.
6. The CDR / Bid Security / Earnest Money amounting to **Rs. 100,000/-**, uploaded online with the bid, shall also be submitted in original to the Cantonment Board Wah (CB Care Centre) on the same day, prior to the cut-off time, in the form of a Demand Draft / CDR / Pay Order, before the opening of bids, in accordance with PPRA Rule 25. In case of failure to submit the original Bid Security within the

stipulated time, the bidder shall not be qualified for bid opening and shall be liable to forfeiture of bid security and blacklisting for sabotaging the tendering process, as per applicable rules

7. The supplier should be required to supply medicines to Cantt Board Wah on its demand and submit the bill to the Cantt Executive Officer for payment.
8. The Executive Officer, Cantonment Board Wah reserves the right to issue new instruction not Included in the contract during the contract period.
9. If the supplier wishes to discontinue contract, he will give a written notice of at least one month before.
10. At any instance, if the price quoted in bills is found higher than those approved by Ministry of Health, administrative action will be taken as deemed appropriate.
11. The approved contractor / chemist has to execute contract on non-judicial stamp paper for contract agreement within fifteen days of approval of Competent Authority.
12. The contractor / chemist will be fully responsible to supply medicines of standard quality and the brands as prescribed, having sufficient remaining shelf-life. Punitive action will be taken as per law in case the supply is found to be substandard or spurious. Smuggled medicines and the prescription not registered with Ministry of Health, will neither be stocked nor supplied.
