1. Pakistan Airports Authority (PAA) invites tenders for work "**JOINT FILLING CRACK FILLING AND SURFACE REPAIR/MAINTENANCE WORKS ON OLD APRON AT QIAP QUETTA**" as per following details:

2. The bidders are required to attach and submit following documents, electronically and physically.

- a) Scanned copy of CNIC, and attested copy to be submitted.
- b) Scanned original valid PEC license, and attested copy to be submitted. **(C-6 or above)**
- c) Attested copy of valid NTN Certificate.
- d) Attested copy of valid professional tax certificate.
- e) Affidavit for no blacklisting and litigation.

(Documentary evidences of all these are to be submitted and uploaded along with bid)

3. Bids must be submitted electronically via EPADS using the submission type "**Uploading (Files)**". Bidding documents can be downloaded from <https://eprocure.gov.pk>. Physical/hard copy of tenders in sealed envelopes signed by the submitting contractor/firm addressed to the office of Divisional Engineer (Civil) ES QIAP Quetta are also required to be submitted in office within due date and time. Bids not uploaded via EPADS and submitted only physically shall not be entertained.

4. Bidders are required to get registered at E-PADS PPRA (Federal) to access the bidding documents and other relevant information including electronic bid submission. Conditional bids / non-compliant bids of the terms and conditions shall not be entertained and will be liable for rejection and will not be accepted.

5. The original bid Security in the form of bank draft or pay order in favor of "Pakistan Airports Authority" must be submitted in the office address mentioned below, before the bid closing date and time. Tenders without receipt of the original Bid security inside the sealed bid before the closing date and time shall not be entertained. A scanned copy of the Bid Security shall also be uploaded on EPADS along with submission of bids.

6. Physical/hard copy of tenders in sealed envelopes signed by the submitting contractor/firm addressed to the office of Divisional Engineer (Civil) ES QIAP Quetta are also required to be submitted in office along with uploading via EPADS within due date and time

8. Bidders are also required to submit one sealed hard copy of the bid /proposals uploaded on EPADS in separate sealed envelops in the office of address mentioned below before the bid closing date and time.
