3. All interested parties are required to deposit earnest money of Rs.15,000/- in shape of cash with Cashier of this Court at Principal Seat Islamabad before auction day i.e. 30.01.2026 (Friday). The earnest money will be refundable to the unsuccessful bidders.
4. The successful bidder shall deposit 50% of the total bid amount which shall include the earnest money in the form of a Pay Order with the Cashier of this Court at the Principal Seat, Islamabad, in the name of the Registrar, Supreme Court of Pakistan.
5. The remaining 50% amount of bid/sale will be deposited in shape of pay order in the name of Registrar, Supreme Court of Pakistan within 3 working days from the date of auction, failing which bid money deposited on the day of auction will be forfeited.
