Bid guarantee or an equivalent amount as per IB Clause 15 in a freely convertible currency in the form of bank guarantee on bid security form or in the form of deposit at call or from a foreign bank duly counter guaranteed by a schedule bank of Pakistan in favor of CEO LESKO, must be submitted (in original) on or before the bid submission deadline date and time. However, the scanned copy of Bid Guarantee to be uploaded with Electronic Bids through E-PADS System.
6. Bids will be opened publicly at the same day and time as mentioned above in the presence of bidders or their representatives who wish to attend the same. Any bid received after the deadline for submission of bids shall be rejected. (NOTE: The bids not received/submitted through E-PADS will not be accepted).
