The consulting services ("the Services") include consultancy services for Livelihood Restoration Development Specialist to support NHA's PIU and EALS Unit to provide technical, analytical, and coordination support in ensuring Component I activities, in particular the PTEx and SLR in Khyber Pakhtunkhwa (KP), are designed and implemented to meet the Government of Pakistan laws and the World Bank operational policy frameworks and requirements on social development and resettlement. The duration of contract will be for two years. The consultant will work with the NHA as per agreement to carry out the tasks outlined in the TOR.


