- Preferably Enlisted with MES in Cat A, B, C, D (in case of non-enlisted firms, 2% bid security will be provided (Refundable).
- Pre-qualified with Engineer-in-Chief's Branch GHQ Rwp.
- No special report of DI&E & No outstanding DI&E recoveries.

5. Tender will be issued to Pre-qualified firms / contractor and are required to be received in CMES (DP) Taxila at 1130 hours on 02 Mar 2026 and will be opened on the same date at 1200 hours.
