In case of non-compliance of the purchase order, earnest money will be forfeited and purchase order will be treated as cancelled.
2. Bids received without earnest money and after due date and time shall not be entertained.
3. The competent authority reserves the right to reject any or all the bids in accordance with Rule 33 of Public Procurement Rules.
4. Bidders can quote new toner part number instead of obsolete toner part number.
5. Bid provided of each item shall be marked with the price inclusive of all taxes. The purchase order shall be issued independently to the lowest bidder of each item.
6. Supply of said items shall be made within two weeks of issuance of purchase order by NESPAK.
7. NESPAK reserves the right to increase/decrease quantity of each item and this bid is valid for 3 months.
8. No advance payment given by NESPAK. Payment will released within four weeks after submitting of invoice with Annex. C as per purchase order.
9. Sales Tax, Income Tax and other Taxes shall be deducted as per Government rules.
