



## INVITATION TO E-BID

1. The Pakistan Water and Power Development Authority (WAPDA) through **Chief Resident Representative (General Manager Finance Coord WAPDA)** intends to hire Clearing and Forwarding Agent for the clearing of imported consignments/ goods from Seaports in Karachi and airports in Karachi, Lahore and Islamabad.
  2. WAPDA accordingly invites electronic bids through **EPADS v2.0** for appointment of a Custom Clearing Agent initially for a period of two years (2026-28) on **'Single Stage Two Envelopes Procedure'** under **'Quality Cost Based Selection Method (QCBS)'** on National Competitive Bidding (NCB) from the eligible Custom Clearing & Forwarding Agents / Firms having a valid custom licence, five years experience of Custom Clearance of heavy machinery, power plant equipment, transformers and spare parts, registered with Income and Sales Tax departments and appearing in Active Tax Payer (ATL) list of FBR and for this purpose request for proposal (RFP) is being issued.
  3. E-Bidding documents, containing detailed terms and condition, specifications and requirements etc. are available on **e-Pak Acquisition and Disposal System (EPADS)** at **<https://vendors.epads.gov.pk>**.
  4. The bidders may seek clarification if required, on bidding document prior to 03 days closing / deadline of bid.
  5. Each bidder shall furnish a bid Security of PKR.200,000.00 (Rupees Two Hundred Thousand Only) in shape of a **Pay Order, Call at Deposit** in favour of "Chief Resident Representative WAPDA" issued by any scheduled Bank recognized by the State Bank of Pakistan (SBP). A copy of the Bid Security must be uploaded on **EPADS v2.0** in PDF Format. The Original Bid Security shall be submitted to the office of the undersigned on or before the closing date & time.
  6. The e-bids, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through **EPADS v2.0** on or before **Monday, February 9, 2026 12:00 PM**. E-bids will be opened on the same day at **Monday, February 9, 2026 12:30 PM**. Manual submission of Bids shall not be entertained.
- In terms of Rules 65 of Public Procurement Rules 2025 Grievance Redressal Committee (GRC) is notified for the subject procurement and notification copy is available on the procuring agency's website and also available on **EPADS v2.0** as well as Authority's website at ([www.ppra.org.pk](http://www.ppra.org.pk)).
