**MINUTES OF THE MEETING OF PROCUREMENT COMMITTEE

A meeting of the Procurement Committee, constituted for procurement under ADP Scheme No. 721/2025-26 titled "Rehabilitation of Government Special Education & Rehabilitation Complex, Gulistan-e-Johar, Karachi," with an approved cost of Rs. 20.000 (Rupees Twenty Million only), was held on 05th March, 2026 at 11:00 AM in the office of the Director, Government Special Education & Rehabilitation Complex (GSE&RC), Gulistan-e-Johar, Karachi.

The meeting was convened by Chairperson of Procurement Committee to deliberate upon matters relating to the procurement of items under the Revenue Component of the scheme and to ensure that the procurement process is carried out strictly in accordance with the SPPRA Rules, 2010.


PROCEEDINGS OF THE MEETING

At the outset, the Chair welcomed the participants and emphasized the importance of transparent, competitive and timely procurement for the effective implementation of the ADP scheme. The participants introduced themselves and expressed their commitment to ensure compliance with the relevant procurement rules and government procedures.

The Chair briefed the members regarding the objectives of ADP Scheme No. 721/2025-26, which aims to rehabilitate and improve the infrastructure and facilities of the Government Special Education & Rehabilitation Complex, Gulistan-e-Johar, Karachi in order to enhance the educational and

rehabilitation services provided to differently-abled children enrolled at the G.S.E&R, Complex, Gulistan-e-Johar, Karachi.

The committee discussed in detail the procurement of items proposed under the Revenue Component of the scheme, including Furniture & Fixture, Office Equipment, Kids Learning Material and Gyms and Sports Equipment items required for the G.S.E&R, Complex, Gulistan-e-Johar, Karachi. During the meeting, the Mandatory and Eligibility Criteria for bidders were presented before the committee. The same were carefully examined and deliberated upon by all members of the Procurement Committee in light of the relevant provisions of rules. After detailed discussion, the Mandatory and Eligibility Criteria were finalized and unanimously agreed by the committee, which are placed at **Annexure-I**.

Furthermore, the Evaluation / Qualification Sheet along with the Draft of Tender Notice prepared for initiating the procurement proceedings were also placed before the committee. After careful review, the committee expressed its satisfaction and approved the same. The Evaluation / Qualification Sheet and Draft Tender Notice are placed at **Annexure-II**.

The committee further resolved that the procurement shall be carried out through Open Competitive Bidding in order to ensure transparency and maximum competition among bidders. It was also decided that the bidding process shall follow the Single Stage – Two Envelope Procedure, whereby the technical and financial proposals shall be submitted separately in sealed envelopes accordingly.

The committee further decided that the Tender Notice shall be published on the SPPRA website and in widely circulated newspapers in accordance with the provisions of the rules to ensure transparency and adequate participation of eligible bidders.

The members reiterated that all subsequent procurement activities including issuance of bidding documents, bid opening, technical evaluation, financial evaluation and award of contract shall be carried out strictly in accordance with the Rules.


No other matter was brought forward for discussion with the permission of the Chair.

8. Affidavit on Judicial Stamp Paper of Rs. 500/- stating that the firm/company has not been blacklisted and is not involved in any litigation with any Government department or entity.
9. Bid Security/Earnest Money (generally 2% of the total bid amount) in accordance with SPPRA Rules. Original Pay Order/CDR must be presented at the time of bid opening.
10. Minimum three (03) years of relevant experience in the concerned category, supported by copies of previous supply/work orders.
11. Bank statement of the last six (06) months or Bank Certificate as proof of financial soundness.
12. Original catalogues/brochures of the offered items along with detailed technical specifications.
13. Minimum one (01) year warranty for Equipment, Gym & Sports Equipment, and Furniture categories (where applicable).




