Eligibility/Qualification Criteria for Security Guard Firm

The Firm/bidder must have a valid income Tax Registration with the Federal Board of Revenue (FBR) and must be listed as an Active Taxpayer on the FBR website. Additionally, the firm must have a verifiable experience of at least 10 years. The firm/bidder should be registered with registration of firms office and N.O.C. form Ministry of Interior, Govt. of Pakistan, Islamabad or Home Department, Provincial Govt. should be provided. The firm/bidder should be registered with Sindh Revenue Board (SRB) and SRB Website. The firm/bidder should submit copy of annual renewal of license to operate as private security agency in Sindh Province upto July, 2025 or June,2026 from Home Department, Government of Sindh.

- 1) Firm/bidder should be registered with Pakistan Telecommunication Authority (PTA).
- 2) Firm/bidder should be registered with Employees Old Age Benefit Institution (EOBI)
