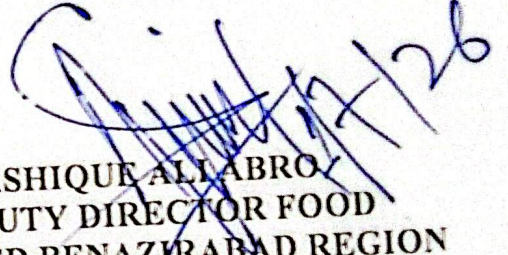

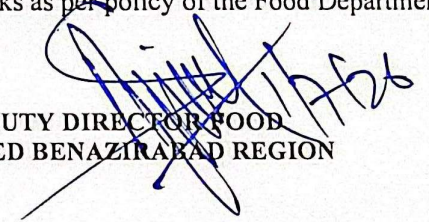

Tenders are invited for fumigation of wheat stocks and recurrence of Fumigation Wheat stocks where Fumigation once has been applied alongside the spraying of godowns against flying and creeping insects, and rodents (on-need basis), using registered chemicals duly approved by concerned department of the Provincial / Federal Governments under the terms & conditions contained herewith.

The tenderer shall be required to treat godowns, wheat stocks, bardana etc. stored therein using approved safe pesticides.

The bidder, shall be required to fumigate commodities and spray godowns inside/ outside, walls & floor as may be required at the following districts of Shaheed Benazirabad Food Region:-

TERMS AND CONDITIONS OF TENDERS:

1. This tender form and the schedule(s) list of work should be signed with the name of person and firms Rubber stamp, with Registration number.
2. The tenders shall be submitted in the tender form and the attached schedule(s) list of work duly and properly filled and signed.
3. The bidders are required to offer their Electronic bids through E-Pak Acquisition & Disposal System (E-PADS) under Single Stage Two envelop procedure for the Fumigation of wheat for the tender year 2026-2027 up-to the period 09 months from the date of contract award.
4. Bid Security of the amount shown in the brief description of work attached with tender form issued in favor of the Deputy Director Food Shaheed Benzirabad must be submitted through E-PADS electronically through SPPRA EPADS Portal (<http://eprocure.gov.pk>).

5. Incomplete tender(s) schedule(s) shall not be entertained, and condition or alteration, cutting of words or figures, erasing and insertion of any remarks on the tender form(s) schedule(s) will not be accepted and such tenders shall be rejected.
6. Offers once submitted shall not be allowed to be withdrawn. In case any offer is withdrawn, after opening but within the period of bid validity, the bid security of the tenderer will be forfeited & the losses if any, that may accrue to Government by such withdrawal shall be payable by the party/firm concerned.
7. Rate and amount of security deposits should be quoted both in figures and in words in the schedule/work attached **Annexure-A** with this tender form and rate shall be considered subject to the provision of required security deposit only.
8. The rate offered by the contractor shall be inclusive of all taxes and duties (Federal & Provincial).
9. The successful bidder shall be required to provide onsite all necessary material and chemical, skilled labor & transport for the completion of the work which shall include fumigant tablets, pesticides, polythene sheets, sealing machine & sand bags of (5" x 36" or any required size), equipments for spraying, labor etc.
10. The bidder shall be required to provide complete breakup of cost to be incurred on the assignment. No other cost other than those specified in the offer will be accepted.
11. The firm/company already under take the fumigation work in the Food Department for Last year, they shall provide Performance/ No Dues Certificate " from authority of execute agreement.
12. The offer shall be valid for a period of 90 days from the date of opening of tender, which is extendable by the competent authority i.e. Procuring Authority, as per relevant rules of SPPRA (up to date).
13. The bidder shall be required to complete fumigation in a timely manner not exceeding two weeks to complete one store with all equipment removed from the area once job is completed to allow access to the commodities.
14. The rate shall be quoted per metric ton of wheat including Jute/PP bags (gross weight) including all expenses related to the required service, including cost of material viz. fumigant tablets / pesticides / spraying chemicals / polythene sheets etc. of prescribed specification as at (Para-09) above and its transportation and accommodation of personnel and equipment at the locations mentioned above.
15. (The spray shall be based / carried out on surface area rather than volume of warehouse of such godowns and that Food Department shall be allowed access to all chemicals fumigation sheets Phosphide gas measurement as well as relative Quality Control Equipments.
16. The contractor shall be required to carry out fumigation by applying dose at minimum 3 gram / cubic meter for under sheet fumigation.
17. The contractor shall ensure cleaning / sweeping of godowns surface before and after fumigation/ pesticide application. The contractor shall also ensure spraying after two months interval (total three sprays).

1. SPECIFICATION:

I. Aluminum Phosphide Tablets Description.

- a. Aluminum Phosphide content by weight JAOAC 26:559 (1943) Min: 56%.
- b. Aluminum Phosphide Tablet to contain Pb, Cd and As within permissible limit.
- c. Inert substances as hydrophebio and fire retardant agent - Max: 44% and tablets aids.
- d. Weight of each tablet shall be 3 grams and shall evolve one gram Phosphide on exposure to atmospheric condition.
- e. Total release of PH₃ gas: 33%.
- f. Evolving of PH₃ gas shall stop after 120 hours unpacking of tablets, Ash must contain pb, Cd, and As within permissible limits.
- g. Tablets when exposed to atmospheric humidity and temperature shall not show any evidence of spontaneous combustion.
- h. Tablets must be resistant against abrasion and shall not be in a broken condition when unpacked.

II. Methyl Bromide (CH₃Br).

III. Delta Methrine 25 EC.

IV. Polythene Sheets.

Made of pure grain, minimum 0.1 mm thick in single ply, Low Density, Transparent, Tubular, 14 feet wide (07 feet double ply tubular).

(The Polythene Sheet shall be in color without affecting transparency).

2. PERIOD OF CONTRACT

- I. The contract shall be valid for 09 months from the date of commencement of fumigation.
- II. The contractor shall be responsible that stocks are safe for a period of 09 months after the fumigation. In case of unsatisfactory results, the contractor shall be responsible to repeat fumigation at his own expenses and without any extra cost to the department.
- III. The contractor shall be responsible for all the losses accrued to the department on account of unsatisfactory fumigation as at (II) above, the contractor shall be responsible to bear all the charges/ cost arising due to non-performance/ poor performance of the contractor.
- IV. The contract shall be extendable as per provision of SPPRA Rules 2010 amended upto date.
- V. The bidder shall be required to provide detail report for the each fumigation / spraying services provided under this agreement.
- VI. The Government of Sindh, Food Department & its employees shall be exempt from any liability in respect of any direct, indirect or consequential loss and / or damaged and / or injury sustained by the contractor, its employees, agents or any third party arising from this agreement or the performance thereof which is undertaken entirely at the risk of the contractor, its agents or employees. Should any claim arise, the contractor shall indemnify and hold harmless the Government of Sindh, Food Department and its employees, from any liability.
- VII. The contractor shall assume full responsibility for any fraudulent and / or illegal acts it commits knowingly / un-knowingly and Food Department shall be exempt for any liability whatsoever in this respect.

3. BID SECURITY:

- I. The bid security of amount as shown in the Annexure-A in the form of Call deposit or pay order or demand draft in the name of Deputy Director Food Shaheed Benazirabad Region and the required documents must be submitted by using EPADS Electronically through SPPRA EPADS Portal (<http://eprocure.gov.pk>) and original bid security along with a set of documents required in technical proposal must reach at the office of Deputy Director Food Shaheed Benazirabad located at Habib Suggur Mill Road Nawabshah, before deadline for submission of bids. Bids of the bidders failed to submit bid security by the deadline shall be rejected.
- II. However, Bid Security will be refunded to the unsuccessful bidders after awarding of contract to the successful bidders.

4. PERFORMANC SECURITY:

The successful contractor shall be required to pay Performance Security @ 10% of the value of contract.

5. AGREEMENT

- I. If the successful parties / bidders fail to execute an agreement with the Food Department within seven days of bid acceptance, his Security Deposit will be forfeited in favor of Government after due Notice. The Security Deposit of lowest bidder should not be returned till an agreement is executed with the successful bidder.
- II. After acceptance of the lowest rates, the successful party will be required to commence the work as directed and execute an agreement with the Government on non-judicial stamp paper which will be supplied by the party within (7 days) seven days of the acceptance letter and affix adhesive at 0.35% stamp duty of the value of the contract or as per prescribed relevant rules.
- III. The purchase/ tender committee reserve the right to add or substitute any clause of the agreement in the interest of Government work and public utility.
- IV. The respective District Food Controller of Shaheed Benazirabad Region shall execute the agreement which may recover from the contractor as compensation such sums as he may consider recoverable, if any stock entrusted to the contractor under the agreement got damaged due to poor performance of Fumigation work. In case the damaged / losses assessed are more than the amount of the security deposit and amount of the un-paid bills, the contractor shall pay the balance within the period specified by the respective District Food Controller / Deputy Director. In case of default the Government dues shall be recovered as arrears of Land Revenue.

6. ISSUE OF WORK ORDER:

- I. After the tender is approved, agreement signed and security deposited in full, the District Food Controller of the concerned District shall in accordance with the allocation made by the competent authority, issue work order in the prescribed proforma indicating the specific quantity to be Fumigated upto a particular date.

7. LAW & ARBITRATION:

- I. This agreement and any dispute arising there in shall be governed by general principle of law of the Arbitration Act. Any arbitration award rendered in accordance with the provision of this articles/ Arbitration Act shall be final and binding on the parties.
- II. Any non-performance related to the terms & conditions of this agreement by the contract shall be deemed as a breach of the contract and agreement may be terminated immediately and that the security deposit shall be forfeited to govt.

8. SUBMISSIONS OF BILLS AND PAYMENTS.

- I. The Payments to the firm/ company shall be made subject to successful/ satisfactory completion of fumigation of Government wheat stocks duly endorsed by the inspection committee constituted at Regional level including member either from PARC or Department of the Plant protection or both.
- II. The successful bidders will pay the amount @ Rs.10/- per tone to PARC "As Supervision/ Service Charges" on account of fumigation of wheat stocks and the amount will be deducted from their bills, The bidder shall be required to submit satisfactory performance certificate from PARC during period of his contract showing therein the satisfactory services provided and applied to the wheat stocks during fumigation, which will be enclosed with the bill.
- III. No advance payment will be admissible subject to submission of inspection report of committee as mentioned at Para-8(I) above.
- IV. Part payment on completion of one godown shall be admissible.
- V. The Food Department reserve the right to withdraw the contract in whole or in part in case the successful bidder is unable to provide required capacity necessary, and/ or fails to deliver the services within the specified period of time and/ or is unable to provide the full agreed services.
- VI. In case the Regional Directorate of Food Shaheed Benazirabad considers that the services of the contractor are no more required further, the Deputy Director Food may terminate the agreement by giving written notice to the contractor on which no claim or compensation shall be admissible.

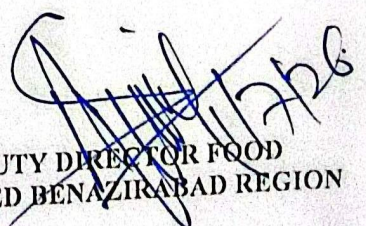
