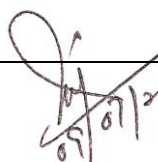

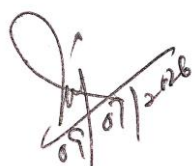

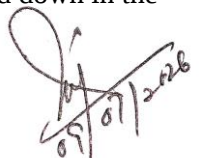

1. Tender is invited as per rule # 46(1) of SPPRA Rules 2010 (as amended) (Single stage one envelope bidding procedure).

3. Earnest money @ 2.5% of the bid price as bid security in the shape of Pay order/Demand Draft in the name of Superintendent, Remand Home & Certified School, Karachi should be attached with the Tender Form.
4. Personal Cheque/C.D.R/Bank Guarantee will not be accepted in any case.
5. The tender must be free from erasing, cutting and over writing. In case of erasing, cutting and over writing authorized person should initial it.
6. Tender must be filled in with Blue or Black ink in the column provided.
7. The quoted rates must be valid up to 24-07-2026.
8. Approved Contractor will supply dry food articles according to daily strength of the child inmates and he will not make any representation regarding the strength if falls short.
9. Approved Contractor or his representative will supply fresh and good quality items to the institution on daily basis as per schedule duly weighted to the representative of the Superintendent, Remand Home & Certified School Karachi. Fresh and seasonal vegetables as per scheduled may be supplied. Poor/Bad quality vegetable will be rejected.
10. The Superintendent, Remand Home & Certified School, Karachi reserves the rights to drop partly/full quantity from the tender items as to make his requirements from any other sources on risks and cost of the contractor.
11. The approved contractor will store a minimum one week reasonable stock of dry food, commodities and other items in a store room of the Remand Home Karachi for all items and which can be inspected by the Superintendent, Remand Home & Certified School, Karachi or his nominee as and when he likes.
12. The Procuring Committee/Agency has reserved the rights to accept or reject any or all tenders without assigning any reason.

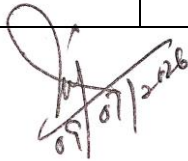

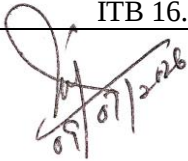
