The bid along with bid security of amount as shown above and tender fee of Rs.5,000/= (Non-Refundable for each tender form) both separately in the form of Call deposit or Pay Order or demand draft in the favour of Deputy Director Food Larkana Region and the required documents must be submitted by using EPADS Electronically through SPPRA E-PADS Portal (<http://eprocure.gov.pk>) and **original bid security** and tender fee must reach at the office of Deputy Director Food Larkana located at 2nd Floor, Commissioner Building, Larkana, before deadline for submission of bids. Bids of the bidders failed to submit bid security by the deadline shall be rejected. However, Bid Security will be refunded to the unsuccessful bidders after awarding of contract to the successful bidders. Bid security of the successful bidder shall be retained in lieu of the performance security.

For tendering the Bids, following terms and conditions should also be fulfilled.

1. Bidders must be registered with FBR and SRB for Income Tax, sales tax and services tax and must be on Active Tax payer list of FBR and SRB.
2. The Bid shall remain valid for the period of 90 days after the date of bid opening.
3. The rate per bag of 101 kg gross should be quoted in words as well as figures and shall include the transportation/ loading/ unloading proper stacking at center/ inside godowns or on open plinths to the level up-to 15 to 18 bags high, or in shape of Gunjee stacking besides collection of sweeping stitching of torn/slack bags with cost of sutlie and any other charges incurred in arranging safety measures against weather/theft/pilferage/accidental/axle load condition or any other damage etc.
4. The successful bidders shall be bound to pay all the admissible taxes (viz, Income Tax, sales Tax, stamp duty etc.) applicable at time of payment.
5. Incomplete tender(s) schedule(s) and incomplete Bid Security amount shall not be entertained and such tenders shall be rejected.

6. The contractor shall load and unload the goods in his own presence or of his assignees(s) representatives(s) etc and will give correct and timely delivery of bags and weight to the Incharge P.R.Centre/Godowns and stack the bags in the godown in countable position. The contractor shall be fully responsible for all en-route shortages or damages etc. and will be required to make good the loss. The recovery of cost of wheat will be made in accordance with the Food Department Government of Sindh Notification No.SO(W)/Recovery/2021 dated 07-05-2021.

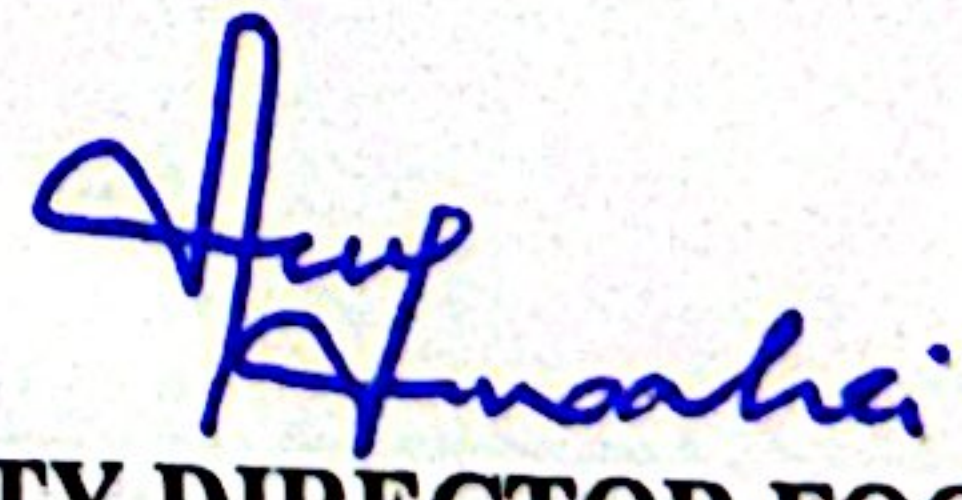
1. REQUIREMENT FOR TECHNICAL PROPOSAL.

- I. Complete profile & history of company showing clear official/residential addresses, telephone numbers and Copy of CNIC(s) of the owner(s) and/or representative(s) of the firm.
 - II. Evidence of Tax payer.
 - III. Evidence of Tax Payer of Sindh Revenue Board (SST).
 - IV. Registration Certificate from Registrar Firm (In case of registered firm/company).
 - V. Bank Statement duly stamped in original showing minimum turnover of Rs. 15 Million Per Annum for last three (3) years of any scheduled Bank.
 - VI. Transport Contractors who have not worked in the Food Department earlier are required to have experience of handling and transportation of wheat or similar nature capacity work during last 03 years, with any Government Department or any established organization which would be verified from the Tax record or the Authority who had obtained such service from the bidder. In such case the contractor is required to provide the Experience Certificate issued from the respective Department/Organization.
 - VII. Transport contractors already working in Food Department will provide the No Dues certificate issued from the Deputy Director Food of respective Region only where they have worked during last 03 years Furthermore those transport contractors who have awarded contract during last three years in Larkana Region will provide No Dues Certificate issued from respective District Food Controller concerned.
 - VIII. **Affidavit on a non-judicial stamp paper of Rs,100/= undertaking following:**
 - I. The firm/ transport contractor should not have been blacklisted by any provincial or federal government department.
 - II. That the bidder/firm is neither blacklisted and nor defaulter with Food Department, Government of Sindh.
 - III. That the bidder/firm will be bound under obligation and sole responsible for completion of awarded work by him/themselves and will not sublet the contract in any case.
 - IV. That the bidder/firm will provide the (03) three specimen signatures of the contractor, the director(s) and or authorized representative(s) of the firm which shall be duly attested by the First Class Magistrate (FCM)/Oath Commissioner.
8. Successful bidder shall submit performance security at 05% on the contract Value (as per bidding documents) in shape of pay Order or Demand Draft or Bank Guarantee in favor of Deputy Director Food, Larkana within the period specified in the Bid / offer acceptance of tender failing which the Bid Security of the bidder may be forfeited.
9. The bidder will have to sign each and every page of tender form and bidding document while submitting his bids.

1. This tender form and the schedule(s) list of work should be signed with the name of person and firms Rubber stamp, with Registration number.
2. The tenders shall be submitted in the tender form and the attached schedule(s) list of work duly and properly filled and signed.
3. The bidders are required to offer their Electronic bids through E-Pak Acquisition & Disposal System (E-PADS) under Single Stage Two envelop procedure for the transportation of wheat for the tender year 2026-2027 up-to 28.02.2027 from the date of contract awarded.
4. Bid Security of the amount shown in the brief description of work attached with tender form issued in favor of the Deputy Director Food Larkana must be submitted through E-PADS electronically through SPPRA EPADS Portal (<http://eprocure.gov.pk>).

5. Incomplete tender(s) schedule(s) shall not be entertained, and condition or alteration, cutting of words or figures, erasing and insertion of any remarks on the tender form(s) schedule(s) will not be accepted and such tenders shall be rejected.
6. Offers once submitted shall not be allowed to be withdrawn. In case any offer is withdrawn, after opening but within the period of bid validity, the bid security of the tenderer will be forfeited & the losses if any, that may accrue to Government by such withdrawal shall be payable by the party/firm concerned.
7. Rate and amount of security deposits should be quoted both in figures and in words in the schedule/ work attached **Annexure-A,B & C**, with this tender form and rate shall be considered subject to the provision of required security deposit only.
8. The rate offered by the contractor shall be inclusive of all taxes and duties (Federal & Provincial).
9. The successful bidder shall be required to provide sources of transportation work for the completion of the work.
10. The bidder shall be required to provide complete breakup of cost to be incurred on the assignment. No other cost other than those specified in the offer will be accepted.
11. The firm/company already under take the transportation work in the Food Department for Last year, they shall provide Performance/ No Dues Certificate to be issued by Deputy Director Food/District Food Controller.
12. The offer shall be valid upto 28.02.2027 from the date of opening of tender, which is extendable by the competent authority i.e. Procuring Authority, as per relevant rules of SPPRA (amended up to date).
13. The bidder shall be required to complete transportation work in a timely manner.
14. The rate shall be quoted per bag of 101 kgs wheat including Jute/PP bags (gross weight) including all expenses related to the required service.
15. The contractor shall be required to undertake transportation work by providing maximum number of vehicles.
16. The contractor shall ensure timely transportation of wheat within shortest possible time by deploying maximum number of vehicles in case of any emergency.

2. PERIOD OF CONTRACT

- I.** The contract shall be valid upto 28.02.2027 from the date of commencement of transportation work / tender award.
- II.** The contractor shall be responsible for completion of transportation work as early as possible.
- III.** The contractor shall be responsible for all the losses occurred to the department on account of unsatisfactory work of transportation, the contractor shall be responsible to bear all the charges/ cost arising due to non-performance/ damages of Government wheat / poor performance of the contractor.
- IV.** The contract shall be extendable as per provision of SPPRA Rules 2010 amended upto date.
- V.** The bidder shall be required to provide detail report for the transportation of wheat services provided under this agreement.
- VI.** The Government of Sindh, Food Department & its employees shall be exempt from any liability in respect of any direct, indirect or consequential loss and / or damaged and / or injury sustained by the contractor, its employees, agents or any third party arising from this agreement or the performance thereof which is undertaken entirely at the risk of the contractor, its agents or employees. Should any claim arise, the contractor shall indemnify and hold harmless the Government of Sindh, Food Department and its employees, from any liability.
- VII.** The contractor shall assume full responsibility for any fraudulent and / or illegal acts it commits knowingly / un-knowingly and Food Department shall be exempt for any liability whatsoever in this respect.

3. BID SECURITY:

- I. - II. However, Bid Security will be refunded to the unsuccessful bidders after awarding of contract to the successful bidders.

4. PERFORMANC SECURITY:

The successful contractor shall be required to pay Performance Security @ 5% of the value of contract.

5. AGREEMENT

- I. If the successful parties / bidders fail to execute an agreement with the Food Department within seven days of bid acceptance, his Security Deposit will be forfeited in favor of Government after due Notice. The Security Deposit of lowest bidder should not be returned till an agreement is executed with the successful bidder.
- II. After acceptance of the lowest rates, the successful party will be required to commence the work as directed and execute an agreement with the Government on non-judicial stamp paper which will be supplied by the party within (7 days) seven days of the acceptance letter and affix adhesive at 0.35% stamp duty of the value of the contract or as per prescribed relevant rules.
- III. The procurement / tender committee reserve the right to add or substitute any clause of the agreement in the interest of Government work and public utility.
- IV. The respective District Food Controllers of Larkana Region shall execute the agreement which may recover from the contractor as compensation such sums as he may consider recoverable, if any stock entrusted to the contractor under the agreement got damaged due to poor performance of transportation work. In case the damaged / losses assessed are more than the amount of the security deposit and amount of the un-paid bills, the contractor shall pay the balance within the period specified by the respective District Food Controller / Deputy Director. In case of default the Government dues shall be recovered as arrears of Land Revenue.

6. ISSUE OF WORK ORDER:

- I. After the tender is approved, agreement signed and security deposited in full, the District Food Controller of the concerned District shall in accordance with the allocation made by the competent authority, issue work order in the prescribed proforma indicating the specific quantity to be shifted.

- II. The successful bidder shall be required to submit satisfactory performance certificate from concerned District Food Controller during period of his contract showing therein the satisfactory services provided and transportation of wheat stocks which will be enclosed with the bill.
- III. No advance payment will be admissible subject to submission of satisfactory / completion certificate to be issued by concerned District Food Controller including reconciliation certificate duly signed by dispatching and receiving end centre incharges duly countersigned by DFC.
- IV. The Food Department reserve the right to withdraw the contract in whole or in part in case the successful bidder is unable to provide required capacity necessary, and/ or fails to deliver the services within the specified period of time and/ or is unable to provide the full agreed services.

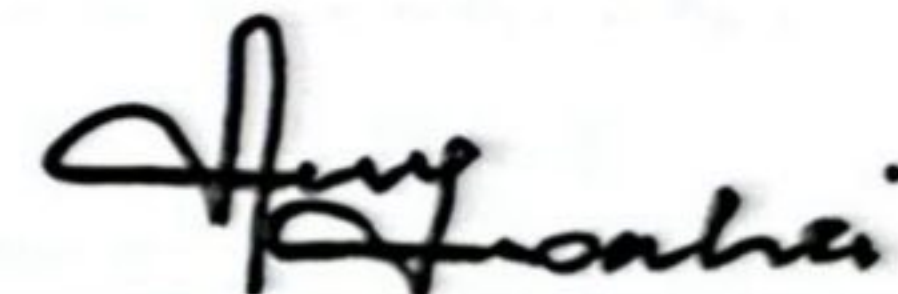

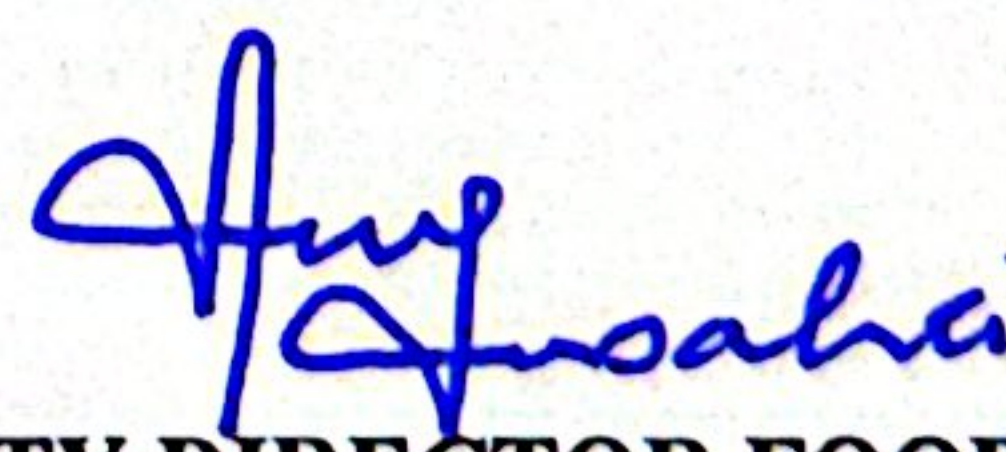

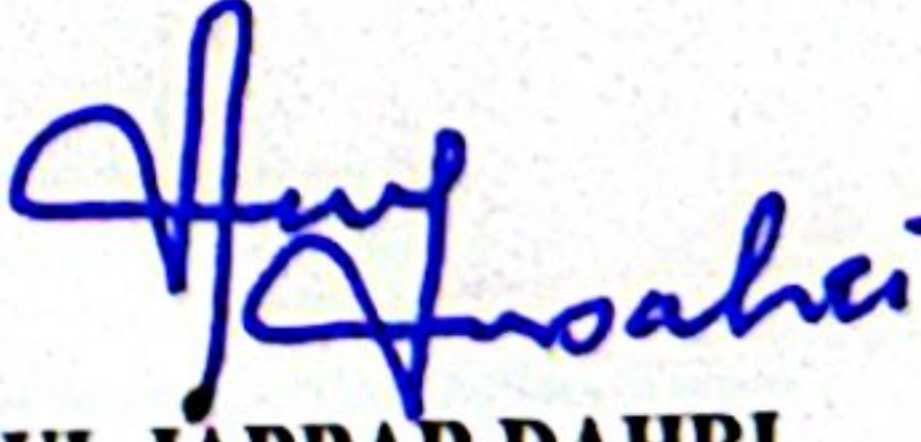
