- The Bidder must arrive at the Board's site at least one (01) hour before the opening of bids, along with one (01) Guard Supervisor and two (02) Security Guards, for presentation before the Committee and Competent Authorities of the Board. In case the Bidder fails to bring the required personnel at the scheduled time, the Bidder shall be considered non-responsive and its bid shall be rejected / disqualified from the bidding process.



PREFERRED STANDARDS FOR SECURITY PERSONNEL

ARMED SECURITY GUARD (EX-ARMY-MAN & SSG-COMMANDO)

- i. Educational qualification minimum Matriculate.
- ii. Ex-SSG Commando from the Armed Forces of Pakistan.
- iii. Should be qualified Army Commando Course.
- iv. The minimum service in SSG should be 10 years.
- v. Field Experience should be a minimum of 5 years.
- vi. Should be able to handle security situations/related matters.
- vii. Medically / physically fit with medical Category "A".
- viii. Preferably from fighting arms like Infantry or Navy Marines with clean conduct sheet.
- ix. Should be able to communicate in Urdu.
- x. Age should not be more than 50 years.

ARMED SECURITY GUARD (CIVILIAN):

- i. Educational qualification should be minimum Matriculate.
- ii. Preferably from fighting arms like Infantry or Navy Marines with clean conduct sheet.
- iii. Relevant experience of 1 year must be in any reputed organization.
- iv. There should be no criminal record/Firs.
- v. Medically / physically fit with medical Category "A".
- vi. Should be able to communicate in Urdu.
- vii. Age not more than 45 years.

LADY SEARCHER

- i. Educated with minimum Intermediate qualification.
- ii. Age between 20 to 45 years.
- iii. Experience of 02 to 03 years working in a similar capacity in any large organization, preferably in an educational institution.
- iv. Should be able to communicate in Urdu.
- v. Should know public safety and security procedures/protocols.

Note: Experience of serving in an educational institution or similar place will be preferred & the Security Agency / Firm ensure that Security Guards must be a Pakistani National, and have valid CNIC.

2. RESOLUTION OF DISPUTES

3. NOTICES

4. PENALTY

- 1) Preferred penalties according to the issue\subject may be imposed upon the Supplier(s) such as:
 - i. rejection of the unsatisfactory Supplied material
 - ii. Blacklisting of the firm
 - iii. Liquidity damages will be imposed as per SPPRA Rules.
 - iv. forfeiting of whole Security amount

Anyone or more than one from the aforesaid penalties may be imposed upon the Supplier(s) in the following cases:

- a) In case of transgression/deviation of the time given in the Contract Award
- b) In case of transgression, deviation, mistake or low quality found in the supplied Item(s)
- c) In case the specification, quantity, rate or stuff of a Tender in certain item or items are approved and the Bidder backs out of his commitment on any pretext or fails to supply the material or complete the job in time or in the required criteria.

5. SUBJECT TO RELEVANT SPPRA RULES, THE COMPETENT AUTHORITY RESERVES THE RIGHT TO:

- (a) divert/distribute a particular work among different Bidders on the lowest approved rate(s) in the interest of the office due to demand of time/situation.
- (b) accept or reject all or any bid.
- (c) increase or decrease quantity without any notice at any time/stage.

6. TERMS & CONDITIONS

- 1) Under following conditions bid will be rejected:-

- i. Conditional and telegraphic bids/tenders.
 - ii. Bids not accompanied by Bid Security of required amount and form.
 - iii. Bids received after specified date and time.
 - iv. Bids of Blacklisted firms.
- 2) Inspection: Security Services will be inspected by Nominated Committee or designated officer of the Board.
- 3) All prices will include all costs of performing the works including labour, material income tax, GST. Octroi charges. Royalties & transportation etc. as mentioned in the agreement.
- 4) No subletting of all or any part of work will be allowed at any cost / reasons.
- 5) Services will be deployed at Board of Intermediate Education Karachi as awarded work.
- 6) The bidder with the "Lowest Evaluated Cost" but not necessarily the "Lowest Submitted Price" shall be awarded the Procurement Contract subject to compatibility/suitability of the item(s).
- 7) The bidder shall provide the security services as per approved specifications mentioned in the Contract Award. If the Guards and their services not found in conformity with the approved specifications shall be rejected at the risk & cost of the bidder.
- 8) The Contract Award may be assigned at any time during the period of bid validity.
- 9) The amount of Performance Security is in addition to the amount of Bid Security which should be deposited by the successful bidder(s). Bid Security shall remain valid for a period of 28 days beyond the validity period for bids.
- 10) Placement of Contract Award will be subject to payment of Performance Security.
- 11) The services should be provided strictly in accordance with the approved schedule.
- 12) SPPRA Rules-2010 (Amended) shall strictly be followed.
- 13) **Disqualification:**

Proposals are liable to be rejected if:

 - a) Bids of the bidders who have been blacklisted or are in process of blacklisting by BIEK shall be rejected;
 - b) Proposals are found conditional or incomplete in any respect;
 - c) Received later than the appointed / fixed, date and a time;

CONTRACT AGREEMENT

Tender Title: Hiring of Security Services

THIS AGREEMENT is executed at KARACHI, on this day, 2026

BETWEEN

Board of Intermediate Education, Karachi, hereinafter called and referred to as "BIEK" (which expression shall wherever the context so permits, be deemed to include its legal representatives, executors, successors and assigns) of the FIRST PART.

AND

M/s, having its office at hereinafter referred to as "THE SERVICE PROVIDER" (which expression shall wherever the context, so permits be deemed to include its legal representatives, executors, successor and assigns), through its proprietor, holding CNIC No. on the SECOND PART.

"BIEK" hereby offer to appoint M/s as their official Services Provider for the specific purpose of "Security Services" in respect of the same with "BIEK" before the determination of the scope of services on a suitable scale with any/all other relevant details for presentation to "BIEK" for services of Security Services. "THE SERVICE PROVIDER" hereby agrees to the offer of the "BIEK" in acceptance of the terms & conditions herein below forth.

WHEREAS

"The BIEK intends to obtain security services to protect its i- premises, ii- property, iii- personnel, iv- students etc. whenever & wherever the security services (hereinafter the "Security Services") required wherever including at the specified locations of BIEK, i.e. Main Building, Library Building, Main Entrance, Parking Area, Counters, Chairman Office, Secretary Office, Controller Office etc. The identified location(s) can be withdrawn or might be added at the discretion of the BIEK. NOW IT IS HEREBY AGREED & DECLARED BY AND BETWEEN THE PARTIES AS FOLLOWS:

AND WHEREAS the Service Provider, having fulfilled all eligibility and qualification requirements, submitted the bid, which has been accepted by the Procuring Agency for an amount of Rs. _____/-
(Rupees _____ Only)
(hereinafter referred to as the "Contract Price").



Article I
DUTIES & SCOPE OF AGREEMENT-I

“THE SERVICE PROVIDER” will provide security services as per BIEK requirements at the following workplaces:

1.2 Main Building, Library Building, Main Entrance, Parking Area, Counters, Chairman Office, Secretary Office, Controller Office etc.

1.3 THE SERVICE PROVIDER will be responsible for providing security services at the desired locations, as per the direction, supervision, of nominated officer / official by Competent Authority of BIEK.

1.4 "THE SERVICE PROVIDER" hereby agrees to attend the meetings with the "BIEK" as & when required

1.5 Staff deputed at BIEK shall be interviewed by the BIEK management prior to their deputation at BIEK.

1.6 BIEK has the right to increase or decrease the quantity, and the service provider is bound to provide without any change in commission percentage.

1.7 BIEK reserves the right to cancel any or all the items mentioned in different categories or may terminate any part of the BoQ or item independently if the required service standards are not met accordingly.

Article II Contract Period

2.1 The services are required for a period of one year upon the satisfaction of the Competent Authority of BIEK. In case of unsatisfactory performance, the services of firm will be terminated at any time with one month prior notice.

2.2 On satisfactory completion of one year, BIEK can renew the contract for another one year with the mutual consent. Contract extendable up to three years.

Article III Terms & Conditions

3.1 Security Company to quote separate rates as per the categories mentioned in the document.

3.2 The successful bidders will furnish a performance security equivalent to 5% (Five Percent) of yearly Contracted Amount. If the successful bidder (s) fails to provide the required services as per TORs, the Performance Security will be forfeited.

3.3 Payment will be made on or after 10th of each month after deduction of all applicable taxes subject to submission of bill(s) along with Satisfactory Certificate, Manual Attendance Sheet duly verified & issued by the concerned officer of the board and Supervisor of the firm on or before 5th of each month. Payment will be made through cross cheque to the firm. The Cheque will post on firm's postal address through courier or will be handed over to authorized person of the firm.

3.4 All applicable tax(es) will be borne by the Service Provider. The firm should be registered with the Income Tax Department.

3.5 No sub-letting/ sub-contracting of services in any form is allowed.

3.6 Stamp Duty @ 0.35% of the cost of transaction / Work order will be deposited in Government treasury by the SUPPLIER. This paid Stamp Duty challan would be submitted along with the Bill / Invoice

3.7 The Firm / Agency / must provide Clearance/ Registration certificate from relevant authorities i.e. Provincial / Federal / Home Department and Interior Ministries, APSAA etc.

3.8 Breakdown of emoluments (Charging for one guard from BIEK) must be given to BIEK by Security Agency / Firm to ensure that guards are given declared amount of pay.

3.9 Any additional manpower required over and above the quantity mentioned in scope of work will be charged at the same rate. Whenever required, THE SERVICE PROVIDER will interchange the manpower from existing trades mentioned in the "Category" as per the requirement of BIEK.

3.10 The Security Agency / Firm ensure that Security Guards must be a Pakistani National, and have valid CNIC

3.11 All Government taxes (including Income tax and stamp duties), levies and charges will be charged as per applicable rates / denomination.

3.12 The attendance would be closed at end of every month to process the bill for the current month by 15th. The attendance will be verified by the BIEK representative, for further processing. The attendance cycle will be on a monthly basis.

3.13 The salary structure, emoluments paid to the Security Personnel contacted to BIEK, Karachi – should be consonant with prevalent Government policies.

3.14 BIEK may purchase / hire / security equipment through the "Security Service Provider" & charges would be paid duly approved by the authority, on submission of quotation(s) / bill(s) / invoice(s).

3.15 The Security Company / Firm will keep the Authority free of any liability for the cause of compensation/ legal course, if any employee of the Security Company claims in case of their Injury, death etc.

3.16 Any claims of injuries, loss of limb or life of labor and other workers engaged/employed by the Security Company for operations under this agreement or work connected directly or indirectly with the agreement shall be settled and paid by the Security Company. The Authority shall in no way be responsible for any compensation in this connection.

Article IV Indemnification

4.1 The "Service Provider" shall indemnify and hold the BIEK harmless from, against and in respect of any losses, costs, liabilities, or damages resulting from any misrepresentation, omission, breach of warranty that the "Security Service Provider" may have given in or under this Agreement, and also against any suit, action, proceeding or demand brought by any third party, including any governmental authority, in connection with this Agreement.

4.2 Further, BIEK shall not have any liability of any unauthorized act or omission by any of the Security Personnel and for the sake of brevity it is hereby acknowledged between the Parties Hiring of Security Services Technical Proposal Tender # BIE/AG/L&N/60/2026 that this Agreement shall not constitute any agency and/or partnership relationship between BIEK and the Security Personnel/" Security Service Provider.



Article V
Arbitration:

The parties expressly consent that in the event of arising a dispute as to the provisions of this Agreement, or any modification hereto, each party shall submit its respective interpretation to the other for consideration. However, in case of any controversy or claim arising out or relating to this Agreement or its breach, shall be resolved through arbitration under the Arbitration Act-1940 and Chairman BIEK, shall have the right to act as arbitrator. His decision will be binding upon both the parties. The Arbitration proceedings will be governed by the Arbitration Act, 1940 and the Substantive and procedural law of Pakistan. The venue shall be Karachi.

Article VI
Termination:

"BIEK" may terminate this agreement if the job is not executed according to the requirement at any time after issuing 15 days' notice. The BIEK may terminate any part of the BoQ or item independently if the required service standards are not met accordingly.

Article VII
Indemnity:

"THE SERVICE PROVIDER" in its individual capacity shall indemnify and keep BIEK and any person claiming through BIEK fully indemnified and harmless from and against all damages, cost and expenses caused to or incurred by "THE SERVICE PROVIDER", as a result of any defect in the title of BIEK or any fault, neglect or omission by the "THE SERVICE PROVIDER" which disturbs or damage the reputation, quality or the standard of services provided by "BIEK" and any person claiming through the BIEK.

Article VIII
Notice:

Any notice given under this AGREEMENT shall be sufficient if it is in writing and if sent by courier or registered mail.

Article IX
Severability:

If any terms covenant or condition of this agreement shall be deemed invalid or unenforceable in a court of law or equity, the remainder of this agreement shall be valid & enforced to the fullest extent permitted by prevailing law.

Article X
Renewal

The contract period for security services is one year. The contract period may be renewed based on satisfactory performance of the company / firm / agency and mutual consent.



Article XI
Payment Terms:

11.1 Payment will be made on monthly basis after submission bill (s) along with verified manual attendance sheet and satisfactory certificate.

11.2 Payments by BIEK shall be made subject to Withholding Tax and other Government levies, in accordance with law.

Article XII
Miscellaneous:

12.1 Any addition & alteration(s) made in the contents as required which entail extra time & labor and material on part of the services, shall be charged separately/extra on 'Quantum Merit' basis before & on final services handed over to the "BIEK". 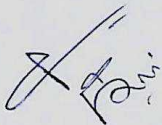

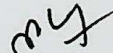
