Project Management Unit (PMU) for Construction of AJK Legislative Assembly Complex Project, Muzaffarabad, AJ&K invites sealed bids on 'Single Stage-Two Envelope' basis from the eligible manufacturers for the **supply and installation of Furniture** for under construction **AJK Legislative Assembly Complex, Muzaffarabad, AJ&K**. The bids are invited under three (03) lots considering the quantum of work. The bidders have to demonstrate their capability exclusively for that very lot, as per the qualification criteria given in the Bidding Documents. In case of duplication of said resources in other lots, the same shall not be considered during evaluation.

2. The bidder must be duly registered with SECP/ AOP/ Registrar of Firms as furniture manufacturer. The bidder must also be registered with FBR for Income Tax and Sales Tax and in Active Tax Payers' List at the time of submission of Bid.

3. The complete set of bidding documents may be purchased by interested eligible bidders upon submission of written application and upon payment of non-refundable cash payment of **Rs. 5,000/-** (Pak rupees five thousand only) **for each Lot** from below-mentioned address starting from **January 14, 2026**.

4. Pre-Bid meeting will be held on **January 21, 2026** at 1100 hours at below-mentioned address.

5. Bids must be submitted in two separate sealed envelopes, clearly marked "**Technical Bid**" and "**Price Bid**", enclosed within a single outer envelope till 1200 hours. Bids will be opened on the same day at 1230 hours at the address and according to the schedule mentioned below. All bids must also be accompanied by a Bid Security in the form of Bank Draft, Call Deposit Receipt (CDR)/ Pay Order or Bank Guarantee from a scheduled bank in Pakistan along with technical bid for each Lot mentioned below:

8. In case of false information provided by the bidder, the concerned firm will be blacklisted/ debarred under PPRA rules, decision of the Employer in the case should be final.

9. Employer reserves the right to accept or reject any or all bids or proposals at any time prior to the acceptance of a bid in accordance with Rule 33 of PPRA AJ&K.
