



Sealed bids are invited for the procurement of Medicines and Allied materials for the financial year 2025-26, which will be received up to 12:00 Noon on 17-02-2026 in the office of the Commandant/Medical Superintendent AK CMH Muzaffarabad and will be opened on the same day at 12:30 pm in the presence of bidders or their authorized representatives who may choose to attend the meeting of bid opening.

1. Bidding shall be conducted through Rule 36(a), Single Stage – One Envelope bidding procedure of AJK Public Procurement Rules. The bid shall comprise one single sealed package containing separately Technical and Financial Proposal, marked clearly as “**TECHNICAL PROPOSAL**” and “**FINANCIAL PROPOSAL**” in bold and legible letters.
2. Manufactures, authorized Importers and authorized distributors can participate according to technical criteria mentioned in the bidding document.
3. A complete set of bidding document including detail specifications, quantity, terms & conditions and evaluation criteria can be obtained from Civil Medical Store SKBZ/CMH Muzaffarabad up till 16-02-2026 during office hours on submission of written application upon payment of Rs. 2000/- (Non-refundable) as bidding document fee.
4. Bid Security/Call Deposit Rs 100,000/- (One hundred thousand Rupees) against Bid Value of Rs. 3,000,000/- (Three million Rupees), will be deposited by each bidder (Manufacture/Distributors/ Importer/Sole Agent) in the name of the Commandant/Medical Superintendent AK CMH Muzaffarabad along with the financial bid. Cheques shall not be accepted.
5. All bidders shall furnish an affidavit /certificate that they are neither black listed nor in conflict with government anywhere in territory of the State of Azad Jammu & Kashmir, Federally administrated areas and provinces of Islamic Republic of Pakistan.
6. All bidders shall furnish an affidavit of that they are accepting all the terms and conditions of Bidding Document.
7. Incomplete bids and bids received after the last date and time will be rejected.
8. Bids shall remain valid for 30.06.2026.
9. All bidders (Manufacture/Distributors/ Importer/Sole Agent) who are not enrolled with AJ&K Income Tax Department considered as Non-Filer in AJ&K.
10. All taxes/ duties levied by GoAJK will be charged from the bills under admissible rules.
11. All bids should be submitted in tape binding duly sealed. All documents should contain proper page marking, attached in sequence should have signatures of authorized person. Moreover, signing and stamping of each page of bidding documents are mandatory. Failure to comply will disqualify the bidder technically.
12. All bidders must attach bid data sheet consisting of complete list of quoted items at beginning of technical bid.
13. Contract will be valid till 30-6-2026.
14. All bidders must attach index having complete page numbers at the beginning of technical bid.
15. It is mandatory for bidders to provide all information related evaluation criteria in one profile with page marking, failure to comply will disqualify the bidder.
