NOTICE FOR INVITING E-BIDDING

(Under Single Stage-Two Envelope E-Bidding System)

“Highways Division Kotli” “Communication & Works, Govt. of Azad Jammu & Kashmir invites Tender via Electronic Bidding Procedure in accordance with AJK PPRA Rules 36(b) as per Single Stage-Two Envelope Bidding Procedure from the eligible Firms/Contractors licensed by the Pakistan Engineering Council and having endorsement in C&W Govt AJ&K for FY 2025-26 in appropriate category as mentioned against work in column 5 below with Specialization Code CE-01 for Roads and Pavement Drainage and Retaining Structures for the following work. A foreign bidder is entitled to participate in the bidding only if having a joint venture with any Pakistani Construction Firm in accordance with the relevant provision of PEC bye-laws. Bidders desirous to bid as Joint Ventures must get prior approval from the Employer for bidding as Joint venture.



- 1 The newly registered bidders are directed to get username and login details from IT Section, Office of The Chief Engineer PWD Highway (North) Block H, DHQ Muzaffarabad. Bidders/Firms which are already electronically registered with the Department can use already provided username & password.
- 2 Bidding Documents and instructions to Bidders can be downloaded from contractor E-bidding dashboard. Moreover, drawing can be obtained from office of the Executive Engineer PWD Highways Division Kotli during office hours
- 3 Interested bidders are required to submit their Electronic Bid (Technical & Financial) up to due date & time mentioned in column 7 above. Technical Bids will be opened by E-Tendering System as per schedule i.e. 12:30 pm on 17/03/2026 as mentioned in column 7 above.
- 4 The interested bidders shall upload scanned copy of Bank Receipt showing proof of deposit of Bid Security in anyone of the following Divisional Joint Account along with their relevant documents on its dashboard.

- 5 The interested bidders shall upload their Technical & Financial Bid complete in all respects on E-Bidding Dashboard. Hard copy of Original Bank Receipts of Bid Security along with Technical Bids, Financial bids & Bidding Documents (uploaded by Highways Division Kotli) duly signed & stamped by the Contractor/Firm must be submitted in the office of the Executive Engineer Highways Division Kotli AJK within 48 hours after opening of Technical Bids through E-Bidding system.
- 6 As E-Bidding software supports only PDF file Format for Technical Profile uploading option, therefore interested bidders shall upload their Technical Bid in PDF file format only.
- 7 The bid securities of unsuccessful bidders will be returned through Divisional Cheque upon award of the contract to the successful bidder(s) or on the expiry of validity of bid, whichever is earlier.

- 8 Electronic Bidding shall be done on **percentage (Above/Below/At par) Basis**.
- 9 Blacklisted Firms/Contractors/Companies/Suppliers/Distributors are not allowed to participate in the bidding process. The interested bidders shall furnish an affidavit/certificate that they are neither blacklisted nor involved in conflict with Govt. anywhere in territory of the state of AJK or in all provinces of Islamic Republic of Pakistan.
- 10 Any Bidder(s) who provides incorrect information or does not submit hard copies of Technical and Financial Bid & Bid Security uploaded on its dashboard along with complete bidding documents shall stand disqualified and shall be banned for two years for participation in any type of bidding procedure.
- 11 Pre Bid meeting will be held on 13/03/2026 at 12:30 P.M in the Office of Executive Engineer PWD Highways Division Kotli.
- 12 Other terms & conditions are available in the bidding documents.
- 13 The competent authority reserves the rights to reject all or any bid under the Clause 33 of AJK PPRA Rules.
