3. It is expected that Invitation to Bid will be issued by August, 2026.
4. Pre-qualification is open to constructors of constructors who are registered with PEC in Category C-3 and above (Code CE-10) for Construction and Operation of Engineering Works, described in para 2 mentioned hereinabove.
5. Prospective bidders are required to get Username and Login detail from IT section, Office of Chief Engineer Building/PHE Muzaffarabad Block "H" DHQ Muzaffarabad and may get necessary training about the bidding procedure. Bidders/Firms which are already electronically registered with the department can use already provided Username and Login.
6. A minimum requirement for pre-qualification will be to have successfully completed at least two (02) projects of similar nature, each having value of PKR 256.000 million or more in last (05) years besides some other requirements which are elaborated in Pre-Qualification document in the case of Joint Venture each number must have one contract of prescribed value to become eligible for consideration.
7. Applications for Pre-Qualification must be uploaded in PDF format on the E-Bidding dashboard of perspective bidder on or before 29th June, 2026 at 11:00 AM. Which will be opened by the E-tendering System and list of participants will be visible to the participant bidders after 11:01 AM on the same day. Hard copies of Applications for Pre-Qualification along with required documents must be provided in original (signed and stamped), within two days after opening of tender on the address of the Employer.
8. Applicants will be informed in writing by fax or mail within 42 days of the date for submission of applications

10. Applicants will be informed, in due course, of the result of the evaluation of applications. Only the firms of constructors prequalified under this process will be invited to bid


