Khyber Pakhtunkhwa Education Monitoring Authority (KPEMA) is an autonomous body established under KPEMA Act 2019 for monitoring of Government Schools in Khyber Pakhtunkhwa.

Sealed Bids are invited from Bidders i.e. firms/companies engaged in cellular services, registered with relevant Registration Authorities and Tax Departments/ Authorities (Income Tax, Sales Tax & KPRA etc).

TWO ENVELOPE PROCEDURES:

- i) The bid shall comprise of a single package containing two separate envelopes. Each envelope shall contain separately the financial proposal and the technical proposal;
- ii) The envelopes shall be marked as “FINANCIAL PROPOSAL” and “TECHNICAL PROPOSAL” in bold and legible letters to avoid confusion;
- iii) Initially, only the envelope marked “TECHNICAL PROPOSAL” shall be opened; technical proposal is to determine the technical strength and consideration of the eligibility of the firm for the bidding process, which is to be carried out before opening of the financial bids.
- iv) The envelope marked as “FINANCIAL PROPOSAL” shall be retained in the custody of Procuring committee without being opened.
- v) The bids shall be received till 12:00 Noon on [30-12-2025] and opened on same day [30-12-2025] at 02:00 PM by the Procurement Committee in the presence of interested parties who may like to attend.
- vi) The Procuring committee shall evaluate the technical proposal, without reference to the price and reject any proposal which do not conform to the specified requirements;
- vii) The Eligible/Technically Qualified Bidders will be considered for further evaluation.
- viii) The financial proposals of bids shall be opened in front of the bidders at a time, date and venue which will be communicated to all bidders.
- ix) 2% bid security of the total bid value should be submitted in favor Director General Khyber Pakhtunkhwa Education Monitoring Authority in the form of Bank Draft (Refundable).
- x) The successful bidder shall be required to deposit eight (8%), of the cost of the contract in the shape of an irrevocable bank guarantee.
- xi) Procurement Committee / Procuring Entity reserves unconditional right to cancel the process at any stage and reject any or all the Tenders after assigning reason thereof and without being liable for any claim / compensation of any nature whatsoever.
- xii) Procurement Committee / Procuring Entity reserves unconditional right to change the specifications/quantity of the above items according to office requirements.
- xiii) In case of any dispute, the decision of the Procurement Committee shall be final and shall not be challenged.
