- The award of contract shall be on the basis of above/ below engineer estimate on MRS-2025 (1" Bi Annual) instead of item rate.
- Earnest money & additional securities shall be prepared in light of KPPRA Notification, No S.R.O. (14)/Vol.1-24/2021-22 dated 10" May, 2022.
- The bid Securities shall be in shape of call deposit receipt in favor of Procuring entity.
- Bids and Original Call Deposit received through fax or by hand will not be acceptable. Sealed bids send through registered mail/ courier service should reach up to specified date and time as mentioned above.
- Sealed bids sent through Registered Mail/Couriers Service should be reached on due date and time (mentioned above) in the presence of bidders or his representative by The Tender Committee.
- These documents are compulsory with tender form: I. Valid Registration of LCB. ii. Valid Registration of KP Revenue Authority BOQ duly signed and stamp. iv. The attested CNIC copy of MD/owner duly attested by Gazetted Officer BPS_17 or above officer v. active NTN/Income Tax certificate.
- After issuing the work order, the contractor/firm will bound to start the work within the period , failing

- which the security deposited will be forfeited .
9. Issuance of work orders/ commencement of work on the above schemes shall be subject to availability of funds.
 10. According to the Government Laws, all the taxes will be deducted.
 11. In case of receiving equal offers, the award of contract shall be decided through a free toss which shall be final.
 12. Any cutting/over-writing on the BOQ will be liable to rejection of the tender and will be declared non-responsive.
 13. The procuring entity may reject all bids or proposals at any time to the acceptance of bids or proposals in light of KPPRA Rules-47.
 14. The rules and regulation/instructions in future if issued by provincial Government of KPK will be applicable.
 15. As per clause 37 (A) of KPPRA Rules. All bidders must be registered with Khyber Pakhtunkhwa Revenue Authority.
 16. As per KPPRA advice insurance bond will not be accepted.
 17. The Contract will be awarded subject to the verification of CDRs from concerned Banks.
 18. Any addition made in terms and conditions in the NIT advertised in the newspaper or published on KPPRA website will be implemented as per KPPRA Rules.

Note: The work order will be issued subject to the release of funds by the provincial government. In case of non-release of funds, with in due time of tender the tendering proceedings will be considered cancelled accordingly.
