**NOTICE INVITING TENDER THROUGH EPADS**


Sealed tenders based on MRS-2025 (1<sup>st</sup> Bi Annual) as per approved PC-I for the below mentioned work out of, **Accelerated Sustainable Development Initiatives (ASDI) ADP Provincial Government** funds are hereby invited on the basis of **Single Stage Single Envelope Procedure** through **EPADS** from the Government contractors registered with PEC, enlisted with C&W Department as per Centralized Enlistment Policy of the Government of Khyber Pakhtunkhwa for the current financial year 2025-2026:

**TERMS AND CONDITIONS:**

- I. Bid solicitation Documents can be downloaded from the official EPADS website i.e. ([www.portalkp.eprocure.gov.pk](http://www.portalkp.eprocure.gov.pk)), after publishing NIT. Bid documents will be filled neatly and a clear scan copy of the same will be uploaded at the time of apply (bid submission) through EPADS.
- II. The bid securities must be prepared in favour of Assistant Director LG&RDD Tehsil Khwazakhela District Swat. A scan copy of the bid securities along with scan copy of bidding documents shall be uploaded on EPADS system the time of bid submission and the original securities along with signed documents must be delivered to the Office of Assistant Director LG&RDD VC/NC Barkalay Village Bhattai Tehsil Khwazakhela District Swat, before closing time of bid.
- III. The bid securities for the work must be prepared after publishing of NIT and before closing time of bid.
- IV. All the bid securities i.e. submitted CDRs for the advertised work will not be released to any contractor before awarding of the contract as per KPPRA Notification S.R.O (29)/vol: 1-40/2025-26 dated 29<sup>th</sup> Oct,2025/699-711.
- V. Rates may be offered as % above, % below or at Par on Engineer's estimate.
- VI. Last date and time for online clarification is 25<sup>th</sup> December 2025,5:00 PM
- VII. The contractors quoting their bids up to a limit of 10% below Engineer's Estimate shall submit bid security @ 2% only of Engineer Estimate.
- VIII. The contractors quoting their bids more than 10% below up to 20% below on Engineers' Estimate shall submit along with their bids 8% Additional Security of Engineer's Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of Government and the second lowest bidder and so on will be considered accordingly. Similarly, a contractor, quoting bid more than 20% below shall submit with his bid an additional security on Engineer's estimated cost equal to the differential amount of submitted bid and Engineers' Estimate along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favour of Government and the 2<sup>nd</sup> lowest bidder and so on will be considered accordingly. In case detailed rate analysis submitted with the bids is, in view of the Procuring Entity, not convincing, the Head of the Procuring Entity may declare such bid as non-responsive without any forfeiture of bid securities and record reasons thereof.

- The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
- IX. In case of rates more than 20% below a detailed rate analysis must be uploaded/submitted along with valid and justifiable supporting documentation.
- X. The contractor or his representative may be present at the time of bid opening.
- XI. In case of tie / draw amongst the responsive bidders, the bid may be decided through free toss which shall be considered as final.
- XII. The bidders must have the relevant category for the execution of works as per PEC.
- XIII. Any bidder who provides false, or materially inaccurate or incomplete or do not send information/bid securities in hard form will be disqualified as per KPPRA Act Section 29 (1) read with KPPRA Rule (43). Furthermore, the Procuring Entity/Executing Agency will recommend and sent cases for debarring/Blacklisting and will initiate / take action in light of approved procedure / mechanism as per KPPRA Act section 29 (2) read with KPPRA Rule (44).
- XIV. Bids will remain valid for 120 days from the closing date of bids.
- XV. Prospective bidders firms/contractors who wish to participate in tendering process must register themselves on EPADS for gaining their unique username and password.
- XVI. The PEC and KPRA registration (Active tax payer) must be valid for the current financial year.
- XVII. All applicable taxes shall be recovered as per directives of government rules in vogue.
- XVIII. Any cutting/overwriting on the tender form/BOQ shall be liable to rejection of the tender and will be declared as non-responsive
- XIX. The Additional security shall be released to the contractor after the completion of approved work and release of final instalment.
- XX. The Work order will be issued to the lowest responsive bidder subject to the availability and release of funds.
- XXI. The successful bidder/contractor shall be responsible to produce satisfactory certificate of the work-done from concerned Chairman before submission of bill for payment.
- XXII. All material testing and all sorts of other tests will be performed by the contractor on the demand of procuring entity.
- XXIII. Any addition made in the terms & conditions in NIT advertised shall be implemented as per KPPRA Act & Rules
