1. Bid Solicitation Documents (BSD) / Bill of Quantity (BOQ) can be downloaded from the official website of EPADS (kp.eprocure.gov.pk) and Khyber Pakhtunkhwa PPRA (kpra.gov.pk).
2. The Earnest money and all the bid securities must be submitted in favor of Assistant Director LG&RDD, Tehsil Headquarter Nowshera in light of KPPRA Notification No.S.R.O. (14)/Vol: 1-24/2021-22 dated 10th May, 2022 and must be delivered to the Office of Assistant Director Senior LG&RDD Nowshera, before closing time of bids.
3. If detailed rate analysis submitted with the bid is found non-responsive, unconvincing, or unjustified, the Procuring Entity may declare the bid non-responsive
4. The bidder must upload original tender form along with original Bid securities, CNIC, KPRA enlistment/Registration, C&W enlistment, PEC registration, FBR active taxpayer status, Non Blacklisting & No litigation affidavit & detail rate analysis (If applicable), complete in all respect through EPADS.
5. Cutting/overwriting/manipulation in the bid solicitation documents will not be acceptable, in the scanned copies submitted through EPADS.
6. The rates may be offered as % above/below or at-par on engineer estimate.
7. Each bidder shall submit tender form fee @ 0.03% (Non-refundable) of engineer estimate for each work separately in shape of CDR in the name of Assistant Director Senior LG&RDD Nowshera.
8. The securities shall be in shape of call deposit in favor of the Assistant Director, Local Government and Rural Development Department Headquarter Tehsil Nowshera.
9. The eligible contractors/firms must have relevant codes of Pakistan Engineering Council (PEC).
10. Any electronic bidder who provides false, or materially inaccurate or incomplete or do not send information in hard form will be disqualified as per KPPRA Act Section 29 (1) read with KPPRA Rule (43). Furthermore, the Procuring Entity/Executing Agency will recommend and sent cases for debarring/Blacklisting and will initiate / take action in light of approved procedure / mechanism as per KPPRA Act section 29 (2) read with KPPRA Rule (44).
11. Bids will remain valid for 90 days from the closing date of bids.
12. The firms/contractors who wants to participate in tendering process may registered themselves with the EPADS for gaining their unique username and password.
13. All the bidders must require to be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA) under the Khyber Pakhtunkhwa Finance Act 2013.
14. Pre-Bid meeting will be held on 12<sup>th</sup> December 2025.
