NOTICE INVITING TENDER
SINGLE STAGE SINGLE ENVELOPE SYSTEM

Sealed tenders based on MRS-2025/Non MRS-Items as per approved PC-I for the below mentioned work out of (Annual Sustainable Development Initiative Fund) for the year 2025-26 (MPA PK - 97) are hereby invited on the basis of single stage Single Envelops Procedure from the Government contractor through **electronic bids** via PPRA- EPADs from eligible firms/contractor that meet the following criteria: (i) Valid License/Certification of Pakistan Engineering Council (PEC) in C-6 or above FY-2025-26. (ii). Valid License/Certification of Local Council Board Khyber Pakhtunkhwa Peshawar FY-2025-26 (iii). Valid Professional Tax Certificate from Excise & Taxation Department (iv). Active Taxpayer status on the Federal Board of Revenue (FBR) list. (v). KPRA Registration for 2025-26 (vi). Copy of CNIC (documentary evidences of all of these are to be submitted & uploaded along-with bid).



1. E-bidding documents as per regulations, containing detail terms and conditions, specifications and requirements etc, for the works is available for the registered bidders on EPADs at (www.eprocure.gov.pk).
2. The electronic bids must be submitted by using EPADs on or before 10:30 hours on 22/12/2025. Manual bids, shall not be accepted. **Electronic Bids will be opened on the same day at 11:00 hours** at the Office of Tehsil Municipal Officer, Karak. Bids must be submitted through registered courier to the Engineering Branch of TMA Karak.

TERMS & CONDITION:-

- I. Bids must be submitted electronically via EPADs using the submission type "Uploading (Files)". Bidding documents can be downloaded from <http://kp.eprocure.gov.pk>. Physical/Hard copy of tenders in sealed envelopes signed by the submitting contractor/firm addressed to the office of Tehsil Municipal Officer, TMA Karak are also required to be submitted in office within due date and time. Bid not uploaded via EPADs and submitted only physically shall not be entertained, as well as the bidders are required to provide an original Pay Order/Demand Draft/Bank Slip in favor of TMO TMA Karak amounting to Rs. 500/- (Five Hundred Only) as Documentation Fee against each work/scheme separately.
- II. Bidders are required to get registered at EPADs PPRA(KP) to access the bidding documents and other relevant information including electronic bid submission. Conditional bids/non-complaint bids of the terms and conditions shall not be entertained and will be liable for rejection and will not be accepted.
- III. The 2% Bid Security shall be submitted in the shape of CDR in favor of TMO, TMA Karak(The name of firm must be mentioned on the CDR). The copy of CDR shall be uploaded with electronic bids and original CDR must be submitted to the undersigned on date of bid opening but not later than 11:00 hours, otherwise bid security will not be accepted.
- IV. Physical/Hard copy of tenders in sealed envelopes signed by the submitting contractor/firm addressed to the office of TMO, TMA Karak are also required to be submitted in office along with uploading via EPADs with due date and time.
- V. This Advertisement is also available on PPRA website www.ppra.org.pk.
- VI. Firms/Contractors providing unsubstantiated and/or incorrect information are liable to legal action and/or disqualification. Any Pay order, Bank Draft, or financial instrument submitted by bidders as Bid Security that is found fake or dishonored by the issuing Bank/financial institution at any pre- or post-contract stage will result in blacklisting and legal action as per PPRA rules and regulations.
- VII. The Authority reserves the right to reject all proposals at any time prior to the acceptance of a proposal in accordance with Public Procurement Rules, 2004, Clause 33.
- VIII. The bidder should upload signed & Stamped form of Bid/BOQ/Contract data: other-wise the same will be rejected.
- IX. The bidder shall upload PEC registration, Enlistment Copy of Local Council Board Certificate 2025- 26, Copy of CNIC, KPRA Registration 2025-26 and details of Active Tax Payer and must show the original documents at the time of bid opening. In case of failure his bid will be rejected.
- X. The tender shall be processed according to "above / below system" based on market rate system. The engineer estimates is framed on the current MRS 2025 (1st Bio-annual). Tender forms and BOQs must be signed by the original contractor.
- XI. In case of Solar Project; only those contractors bid shall be entertained, whose Firms have been awarded specified code of Solar and only approved / Registered Company Solar material will be installed.
- XII. The contractors quoting their bids up to a limit of 10% below Engineer estimate shall submit bid security to the extent of 2% of Engineer Estimate only. The contractor quoting their bids more than 10% below up to 20% below on Engineers Estimate shall submit along with their bids 8% Additional Security of Engineers Estimated cost in addition to 2% bid security. If the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favour of TMA Karak and the second lowest bidder and so on will be considered accordingly. Similarly, a contractor quoting bid more than 20%

below shall submit with his bid an additional security on Engineers Estimated cost equal to the differential amount of submitted bid and Engineers Estimate along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and / or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favor of TMA Karak and the 2nd lowest bidder and so on will be considered accordingly.

Note: Work orders of the aforementioned schemes will be issued to the contractor subject to release /availability of fund.
