

1. The firm/contractor must have a valid registration with the Pakistan Engineering Council (PEC) CE-09 code.
2. The firm/contractor must have a valid registration and renewal with the Provincial Enlistment Committee for the year 2024-25.
3. The firm/contractor must be registered with the Khyber Pakhtunkhwa Revenue Authority (KPRA) and have an active tax payer status.
4. The Bid Security and additional security is required to be deposited as per KPPRA Notification NO SRO (14) Vol:1-24/2021-22 dated May 10 2022/6058-71.
5. The Bid security of the bidders shall be retained till the approval of bids.
6. All federal and provincial duties/stamp duty/taxes including sales tax will be recover as per directives of the government issued from time to time.
7. Bidding documents including Tender Form, BOQ can be downloaded from E-pads web site.www.epads.gov.pk
8. Eligible bidders who meet the above requirements are required to submit their original bids through courier, accompanied by the earnest money/stamp duty specified for each work in the form of a call deposit, made out in the name of the undersigned. The original bid and call deposit must be sent to the Executive Engineer, Public Health Engineering Division, by the specified time and date.

Tender documents are to be submitted through a courier service addressed to the XEN PHE Division Buner and must be received **by 12:00 P.M. on 17-12-2025** The tender documents will be opened on the same date at **12:30 P.M.** in the presence of participating contractors/bidders or their authorized representatives.
