



TERMS & CONDIDATIONS:-

1. Bid Solicitation Documents (BSD)/Bidding or Contract Data/Bill of Quantity (BOQ) can be downloaded from the official website of PHED, EPADS (kp.eprocure.gov.pk) and Khyber Pakhtunkhwa PPRA (kppra.gov.pk).
2. The bidder shall submit/upload the bids (by file uploading) through EPADS before last date and time for submission of bid.
3. The bidder shall submit, their original bid security (ies)/additional security (ies), tender form fees (in shape of call deposit receipt, physically in favour of the undersigned) in the office of XEN PHE Division Hangu through registered post/courier, in person or by authorized person before last date and time for bids submission.
4. The contractor/firms while quoting their rates shall submit 2% bid security (CDR) and additional security as per KPPRA notification No.SRO(14)/Vol 1-24/(2021-22) dated 10/05/2022/6058-71.
5. The bidder shall be registered with (1) (EPADS) (1) Khyber Pakhtunkhwa Public Procurement Regulatory Authority (ii) Pakistan Engineering Council (in required category having required codes & renewed as mentioned in the bid solicitation documents) (iv) Khyber Pakhtunkhwa Revenue Authority (KPRA) (status shall be active) (iv) Federal Board of Revenue (FBR) (NTN status shall be active).
6. All notification of the Govt: about taxes and other bidding tender rules/policy of KPPRA will be applicable on tender works.
7. The received bids shall be opened (downloaded from EPADS) on/after the date and time for opening of bids in the presence of bidders or their respective who opt to be present.
8. In-case of identical rate of two or more than two bidders, their bids shall be evaluated on their technical soundness and best performance.
9. Clarification/queries, if any, shall be asked/communicated through EPADS.
10. The competent authority reserves the right to reject any or all the bids by assigning cogent reasons.
