Office of District & Sessions Judge/District Development Committee(DDC), District Upper Chitral, invites sealed bids under national competitive bidding for the procurement/construction/supply/service and installation of the following equipment/project with the approved budget of Access to Justice Development Fund (AJDF), in light of Rule 6 (2) (b) "Single Stage Two Envelops" procedure of KP-PPRA Rules 2014, from contractor/manufacturers/service provider or their Authorized Dealer/suppliers/representative only registered with the Income/ Sales tax and reflected on Active Taxpayer List (ATL) of FBR.

2. The bidders are required to submit bid security (in original) @ 2% of the quoted value in the form of Call Deposit Receipt (CDR), Demand Draft (DD), Pay Order or Bank Guarantee in the name of "District & Sessions Judge/District Development Committee (DDC) District Upper Chitral". An affidavit is mandatory in the technical bid that bid security is placed in the financial bid.
3. Each envelop shall contain separate Technical and Financial Bid clearly marked in bold legible letters. The firms shall provide their complete information along with their postal as well as valid E-mail address and Phone Number on each envelop.
4. Bids should be complete in all respect; proper documentation, bound-volumes and properly mentioned brand, model of each item; shall reach the office of the undersigned by 11:00 hours on 11th December, 2025 (Thursday). Only Technical Bids shall be opened @ 12:00 hours on the same day in the conference room of District & Sessions Judge, Upper Chitral in presence of the members of DDC and the bidders/representatives, who may choose to attend.
5. Incomplete, ambiguous and unbound bids shall be rejected without further processing. The quoted items must be standard quality of a standard brand.
6. The bidders were technically evaluated after opening of bids. Technical Evaluation stage shall include the production and examination of samples.
7. Competent authority reserves the right to reject any or all the bids as per provisions contained in rule 47 of KPPRA Rules 2014.
8. The competent authority may increase/decrease the number of items as per the sanction/released budget of AJDF Scheme.
9. Interested bidders may contact the DDC before submission of bid for any query/confusion on the given official Number i.e. 0943-470316.
10. Delivery/construction and installation of the items may be carried on in District Courts/District Bar Upper Chitral and Tehsil Court/Tehsil Bar Upper Chitral at Mastuj as per direction of DDC, Upper Chitral.
