- Bids and Original call deposit receive by hand will not be acceptable, sealed bids alongwith tender form fee Rs 1000/- through registered mail / courier service should reached to the office of the undersigned upto **11:00 am** dated **11/12/2025** and the tender will be opened on the same day at **11:30 am** in the presence of contractors/authorized representatives. In case of holiday or any other unavoidable circumstances on the opening day, tender will be opened on the next day at same time.
- 02% earnest money in shape of call deposit (in original) in the name of undersigned must be attached with the tender.
- Stamp duty @ Rs.6,250/- should be deposited separately as per Government Rules.
- Incomplete bids / received after due date/time will not be entertained.
- If two or more firms / parties offer the same rate / cost for the above mentioned items then the undersigned reserves the rights to accept the rate / cost of any firm/party.
- The procuring entity may reject all bids or any proposal/Bid at any time prior to the acceptance of a bid or proposals as per KPPRA Rule 47.
