Sealed bids are invited through E-PAD system, under **International Competitive Bidding**, with preference of donor funded agency guidelines (SFD-KSA); from Manufacturers, Sole Agents/ Distributors, and Dealers etc. in Pak.Rupees, authorized as such for the Procurement of Laboratory Equipment/ machinery by Project In-charge, SFD-KSA Scheme (Dr. Roshan Ali, Director ARI Mingora, Swat), Agricultural Research Institute (ARI), Mingora, Swat for the year 2025-26.

Bidding shall be conducted through **Single Stage - Two Envelopes Bidding Procedure** comprising a Single Package Containing Two Envelopes as per KPPRA Rules-2014. Each envelope shall contain separately Technical, and Financial Bid clearly marked in bold/capital legible letters. The bidders are bound to provide complete information along with its registered postal address, and email address(s) as well, and valid phone/cell number(s) (duly active), along with active WhatsApp Nos. on each of the respective envelope.

1. The Interested prospective bidding firms are requested to submit all the relevant documents on or before the closing date and time mentioned. Any bid received without the required documents i.e. photocopies of CNIC, relevant certificates and active taxpayer certificate of FBR and KPRA, will be treated as **NON-RESPONSIVE**.

3. A **Pre-Bid Meeting** with the interested bidders will be held on 23.10.2025, at 11:00 am in the office of Project In-charge/ Director, Agricultural Research Institute (ARI), Takhta Band Road, Mingora, Swat.

Interested Bidders must submit bids on E-PADS and **Sealed** hard copy along with Bid security (Original CDR) to the office of the Project In-charge/ Director, at Agricultural Research Institute (ARI), Takhta Band Road, Mingora, Swat, Khyber Pakhtunkhwa, Pakistan on or before 11:00 am at 25.11.2025, which will be **Opened on the same Day** at 11:30 am in the presence of those arrived bidders or their representatives interested in or other competent authorities who choose to attend the process. Bid submitted after due date and time will not be eligible to be entertained.

Financial bid must be accompanied with **Bid Security** @ of 2% [CDR] of the total submitted bid(s) amount in the name of the Project In-charge via the legally eligible sources as per KPPRA Regulations. Bid Security submitted other than the eligible source i.e. vide ordinary cheque etc. will be liable to rejection summarily.
