GENERAL TERMS AND CONDITIONS:

1. All bids must be submitted electronically via EPADS (kp.eprocure.gov.pk) on or before 17th Dec 2025 at 11:00 am the bids shall be opened on the same day at 11:30 am. Manual submissions of the bids will not be accepted under any circumstances. While preparing the bidding documents, bidder must ensure proper pagination and sequencing in accordance with the Bid Solicitation Documents (BSDs). If deemed necessary at any Stage of the Procurement process, The Procurement Committee may require bidders to present all original/physical bid documents-complementary to the files uploaded via the EPADS portal-for verification and official record purposes.
2. The Two percent (2%) Bid Security of the total quoted amount must be required in the form of a Call Deposit Receipt (CDR) issued by a scheduled bank in favor of “Chief Executive Officer, WSSC Mardan”
3. The original Bid Security shall be scanned and uploaded along with the bid on EPADS (kp.eprocure.gov.pk), the original bid security must be submitted in sealed envelope to the Address: Muhabatabad Bungalow, Opposite Gulberg Town, Muhabbatabad, Mardan before the bid submission time and clearly mentioning the tender title and the bidder's details.
4. Failure to submit the original Bid Security within the deadline will result in rejection of the bid under KPPRA Rules and action will be taken as per KPPRA S.R.O. (29)/Vol:1-40/2025-26 dated 29 Oct 2025.
5. The bid documents must be stamped and signed by an authorized person of the contractor / firm. All federal and provincial duties / stamp duty / taxes will be recoverable as per directives of the government issued from time to time.

6. Any disfiguring / overwriting or manipulation in the tender shall be liable to rejection. Incomplete / conditional bids shall not be acceptable. Other terms and conditions are available with the bidding documents.
7. The Competent Authority reserves the right to reject anyone or all the tenders, the reason for rejection shall be communicated to the Contractor/firm upon request.
