

NOTICE INVITING E-TENDER ON EPADS

E-bids are invited under single stage single envelop from Government registered workshops /Firms / Authorized Dealers for the “**Engine Overhauling and Repairing of Transmission System of Front-End Loader # 2 (Doosan) of Zone-B office WSSP**”.

Terms & Conditions.

1. Interested and eligible bidders / Authorized dealers will be required to register themselves on the EPADS link <https://kp.eprocure.gov.pk/#/supplier/registration> before submitting their bids on EPADS.
2. Bids must be submitted on EPADS on or before **December 30th, 2025, till 11:00 am**. The bids of participating bidders submitted on EPADS (only) will be accepted and opened publicly on 30th December 2025 at 11:30 am.
3. ORIGINAL two (2%) CDR of the total bid price in the name of “**WSSP Contractor Securities**” in sealed envelope marked as such shall reach on below given address before the closing date and time.
4. The interested bidders should deposit a fee of PKR 2000/- (non-refundable) payable in WSSP A/C Bank of Khyber Phase 3 Chowk Hayatabad Peshawar (IBAN # PK49 KHYB 0083 0020 0915 2876) immediately after the publication of the advertisement in newspapers. The deposit slip fee amounting to Rs. 2000/- must be submitted before the closing date and time along with CDR.

7. Subcontracting/subletting of works is not allowed. If the bidder is found to be involved in subcontracting after the award of the Contract (wholly or partially). The awarded contract will be cancelled immediately. The bid security will be forfeited, and the bidder will be recommended for black listing/debarment.
8. The bid must be stamped and signed by an authorised person of the firm. All federal and provincial duties/stamp duty/taxes, including KPRA Taxes, will be recoverable as per directives of the government issued from time to time.
9. The firm must be a registered entity with Income Tax and KPRA. (Rule: 37A of KPPRA Rule 2014).
