
TERMS AND CONDITIONS

1. Bidding Documents along with Tender form can be downloaded from the official EPADS website i.e. (portalsp.procure.gov.pk) after publishing NIT. The tender form will be filled neatly and a clear scan copy of the same will be uploaded at the time of apply (bid submission) through EPADS.
2. A complete set of Bid Solicitation Documents can be obtained by an interested eligible bidder on submission of a written application on bidder official letter head from authorized person upon provision of non-refundable fee of Rs 0.03% call deposit receipt prepared in the name of TMO TMA Matta.
3. The bid securities shall be in the shape of call deposit receipt in favor of the TMO TMA Matta.
4. The Earnest money & additional securities shall be prepared in light of KPPRA Notification No. S.R.O (14) VOL:1-24/2021-22 dated 10th May 2022.
5. Cutting/overwriting/manipulation in the bid solicitation documents will not be acceptable. Any mismatching among the scanned copies submitted through EPADS and that submitted in hard will leads into his disqualification and the same contractor will be considered as non-responsive
6. The firms/contractors who wants to participate in tendering process may registered themselves with the EPAD system.
7. The rates may be offered as %age above or %age below or at-par on engineer estimate.
8. Bids and original call deposits received through fax or by hand will not be acceptable sealed bids sent through registered mail/courier service should be reach up to the specified time and date as mentioned above.
9. The contractor or his representative can be present at time of opening of bids.
10. The Call deposit i.e., bid security for the work/ contract must be prepared after publishing of NIT and before closing time of the bid apply.
11. The bidder shall have the relevant codes as per Pakistan Engineering Council against each mentioned work.
12. The bidder shall submit their bids in sealed envelope within due time and date with requisite mandatory documents i.e., Fresh Registration LCB, Tender Form, BOQ duly signed and stamp, CNIC copy, active NTN/Income Tax Certificate, valid PEC License, and Active KPRA Registration.
13. The quoted rate must be clearly mentioned in words and in figures also on tender and BOQ form.
14. Any bidder who provides false, or materially inaccurate or incomplete bid will be disqualified as per KPPRA rules.

15. The rules & regulation/direction in future if issued by Provincial Government or any competent authority shall be applicable.
16. The Tender Form will not be issued on the opening date of tender and forms issuance will be closed one day before the opening of bids till working hours.
17. If a holiday is declared by the government on the tender opening date, the tender will be opened the next day during office hours.
18. Any addition made in the terms & conditions in the NIT advertised will be implemented as per KPPRA Rules.
19. Work order will be issued, subjected to the availability of the funds.
