1. Bid Solicitation Document scan be downloaded from the EPADS website i.e. (www.eprocure.gov.pk) and KP-PPRA website (www.kppra.gov.pk) after the publication of NIT. The bid documents will be filled neatly and a clear scan copy of the same shall be uploaded at the time of apply through EPADS. Cutting and overwriting in the bid documents shall not be acceptable.
2. The bid securities must be prepared in favor of the Assistant Director LG & RDD Abbottabad. A scan copy of the bid security shall be uploaded on the EPAD system at the time of bid submission and the same must be delivered through registered mail / courier to the Office of the Assistant Director LG&RDD, Abbottabad located near "Sarban Chowk, Link Road Abbottabad" up to the closing time of the bid as mentioned.
3. The bid securities for the work must be prepared after publishing of NIT and before closing time of electronic bid.
4. Rates may be offered as % above or % below or At-Par on Engineer Estimates.
5. Last date and time for Online Clarification is 05:00 PM on 01st January, 2026.
6. Matter pertaining to additional Security shall be in accordance with Notification No. S.R.O.(14)/Vol: 1-24/2021-22 dated 10/05/2022.

7. In case of rates more than 20% below, a detailed rate analysis must be uploaded/submitted along with valid and justifiable supporting documentation.
8. The contractor or his representative can be present at time of opening of electronic bids opening.
9. In case of tie/draw amongst the responsive bidders, the bid may be decided through free toss, which shall be considered as final.
10. Only PESCO registered Contractors / Firms / Workshop are eligible. These schemes shall be executed though only WAPDA registered workshops.
11. Contractors/Firms registered with the Inspectorate of Electricity, Energy & Power Department, Khyber Pakhtunkhwa under the Electricity Act, 1937 (Rule-48), holding a Class-E license, and providing a one-year warranty of the particulars as PESCO SOP are eligible to participate in the tender.
12. The eligible contractors/firms must have the relevant codes EE04 & EE05 as per PEC.
13. Any bidder who provides false, or materially inaccurate or incomplete or do not send bid securities in hard form will be disqualified as per KPPRA Act Section 29 (1) read with KPPRA Rule (43). Furthermore, the Procuring Entity/Executing Agency will recommend and sent cases for debarring/Blacklisting and will initiate / take action in light of approved procedure / mechanism as per KPPRA Act section 29 (2) read with KPPRA Rule (44).
14. Bids will remain valid for 90 days from the closing date of bids.
15. Prospective bidders who wish to participate in the tendering process must register themselves on EPADS in order to obtain a unique username and password.
16. The PEC, FBR and KPRA registration (Active Tax Payer) must be valid for current financial year (2025-26).
17. No bidder shall be allowed to withdraw his bid till award of the contract or till bid is valid, whichever is earlier.
18. Any addition made in the terms & conditions in NIT advertised shall be implemented as per KPPRA Act & Rules.
