



**Terms and Conditions:**

1. Bid Solicitation Documents uploaded by the Office can be downloaded from the official EPADS website i.e. ([www.eprocure.gov.pk](http://www.eprocure.gov.pk)) and KP-PPRA website after publishing NIT. The bid documents will be filled neatly and a clear scanned copy of the same shall be uploaded at the time of apply through EPADS.
2. Cutting and overwriting in the bid documents shall not be acceptable.
3. The bid securities must be prepared in favor of the Assistant Director (Senior), LG&RDD Tehsil Headquarter Kohat, District Kohat. These securities shall be uploaded on the EPAD system at the time of bid submission and the same uploaded original bid security instrument must be physically delivered to the office of undersigned up to deadline for closing of bids as mentioned above.
4. The bid securities for the work must be prepared after publishing of NIT and before closing time of electronic bid.
5. The bid securities must be delivered through courier to the office of Assistant Director (Sr.) LG&RDD Kohat, located at KDA Gate No. 3 District Council Hall, up to the closing time of bid.
6. Rates may be offered as %age above or %age below or At-Par on Engineer Estimates.
7. Last date and time for Online Clarification is **05:00 PM on 2<sup>nd</sup> January, 2025.**
8. Matters related to Bid Security and Additional Security shall be dealt in accordance with KPPRA Notification No. S.R.O. (29) Vol: 1-40/2025-26, dated 29<sup>th</sup> October, 2025 and matters pertaining to Additional Security shall be in accordance with Notification No. S.R.O. (14)/Vol: 1-24/2021-22, dated 10<sup>th</sup> May, 2022.
9. The contractor or his representative can be present at time of opening of electronic bids opening.
10. In case of tie / draw amongst the responsive bidders, the bid may be decided through free toss which shall be considered as final.
11. The bidder must possess the relevant codes for the above mentioned work as per PEC.
12. Any bidder who provides false, or materially inaccurate or incomplete or do not send bid securities in hard form will be disqualified as per KPPRA Act Section 29 (1) read with KPPRA Rule (43). Furthermore, the Procuring Entity/Executing Agency will recommend and sent cases for debarring/Blacklisting and will initiate / take action in light of approved procedure / mechanism as per KPPRA Act section 29 (2) read with KPPRA Rule (44).
13. Bids will remain valid for **90 days** from the closing date of bids.
14. All applicable taxes shall be recovered in accordance with the directives of the government.
15. Prospective bidders who wish to participate in the tendering process must register themselves on EPADS in order to obtain a unique username and password.
16. The PEC and KPRA registration (Active Tax Payer) must be valid for current financial year 2025-26.
17. Any addition made in the terms & conditions in NIT advertised shall be implemented as per KPPRA Act & Rules.
18. All material testing and all sorts of tests will be performed by contractor on the demand of procuring entity.
19. The successful bidder shall be responsible to previews satisfactory certificates of the wrok done from the concerned MPAs.
