(SINGLE STAGE SINGLE ENVELOP)


Executive Engineer Warsak Canals Division Peshawar, Government of Khyber Pakhtunkhwa, invites electronic Bids on EPAD system from the eligible firms/contractors in accordance with Khyber Pakhtunkhwa Procurement Regulatory Authority (KPPRA) rules 2014 on single stage single envelop. The firm / contractor must be register with Pakistan Engineering Council (PEC) for the following works.

TERMS AND CONDITIONS

1. Bid Solicitation Documents containing all the terms and conditions and other relevant instructions for the work can be downloaded from the Department or Khyber Pakhtunkhwa Public Procurement Regulatory Authority websites (www.irrigation.gkp.pk) (www.kppra.gov.pk).
2. The rates may be offered as %age above, %age below or At-Par on engineer estimate.
3. The bidder shall submit their bids on the following address **“Executive Engineer, Warsak Canals Division Peshawar Irrigation Department, Warsak Road Peshawar”** only through reliable courier service on or before the deadline along with required documents as per details mentioned in Bid Solicitation Documents.
4. All bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority.
5. The bidder shall have the relevant codes as per Pakistan Engineering Council.
6. The bidder shall submit 02% bid security of the estimated cost, in the shape of Call deposit (Original) along with their bid before closing date and time in the name of Executive Engineer, Warsak Canals Division Peshawar.
7. Non-refundable bidding entry fee @0.03% of the estimated cost in shape of Call Deposit separately may be furnished (in Original) to this office in the name of Executive Engineer, Warsak Canals Division Peshawar.
8. As Per KPPRA Notification No. S.R.O (29) /Vol: 1-40/2025-26, dated: 29-10-2025 all bidders are required to submit the bid security and the additional security/differential, as already entered in EPADS, to the procuring entity before the closing date and time. In case of failure, the bidder shall be debarred for one year. Furthermore, upon a second violation, the bidder shall be blacklisted for a minimum period of three years.

9. Notifications issued by Khyber Pakhtunkhwa Public Procurement Regulatory Authority pertaining to procurement process issued from time to time shall be applicable.
10. If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through toss.
11. Pre-Bid meeting will be held on **24-12-2025 at 11:00 A.M** in the room of the Executive Engineer, Warsak Canals Division Warsak Road, Peshawar.
12. The last date & time for Submission of the Bid along with relevant documents is **08-01-2026 upto 12:00 Noon** which will be opened on the same day at **12:30 P.M** in the office of Executive Engineer, Warsak Canals Division Warsak Road, Peshawar in presence of Contractors and their representatives who wishes to attend.
13. Administrative Approval & Funds release depends upon policy of Provincial Government hence payment will be made accordingly. Bidder / Contractor agreeing with the financial constraints in respect of payment etc are at liberty to participate in the instant E-Bidding as no claim whatsoever will be entertained in this regard.
14. All Govt. Notifications/Rules/Taxes updated from time to time shall be applicable.
