NOTICE INVITING TENDER THROUGH EPADS

Sealed tenders based on MRS – 2025 (1st Bi – Annual) / Non MRS – items as per approved PC-I for the below mentioned works out of “**District Uplift & Beautification Scheme ADP No.1900/180579**” are hereby invited on the basis of **Single Stage Two Envelope Procedure** through **EPADS** from the Government contractors registered with PEC, enlisted with C&W Department as per Centralized Enlistment Policy of the Government of Khyber Pakhtunkhwa for the current financial year as per following schedule:


Terms & Conditions.

1. Bid Solicitation Documents uploaded by the Office can be downloaded from the official EPADS website i.e. (www.eprocure.gov.pk) and KP-PPRA website after publishing NIT. The bid documents will be filled neatly and a clear scanned copy of the same shall be uploaded at the time of apply through EPADS.
2. The eligible contractors / firms are required to submit their Bids through EPADS as wells as also send their bid in hard and sealed envelopes i.e. one envelope containing “**Technical Proposals**” and clearly marked as “**Technical Bid**” accompanied, while the second envelope containing Financial proposals clearly marked as “**Financial Proposal**”. Both Technical and Financial proposals / bids will be placed in a single sealed envelope and addressed and sent to the **Office Assistant Director (Sr) LG & RDD Headquarter District Tank, Bannu Road Tank** through registered courier service before bid submission due time.
3. The last date and time of submission of electronic tender form is **28th January, 2025 at 12:30 PM**. The date and time of Opening of Financial Bid will be communicated after approval of Technical Bid.
4. Technical proposal must be numbered and a table of contents inserted at beginning of the proposal showing the contents of the proposal according to the numbered pages.
5. Cutting and overwriting in the bid documents shall not be acceptable. Any mismatching among the scanned copies submitted through EPADS and that submitted in hard will leads into disqualification and the same contractor will be considered as non-responsive.
6. The “Technical Proposals / Bids” of the firms / contractors will be evaluated based on criteria mentioned in the bidding Documents.
7. The “**Financial Bids / Proposal**” of only technically responsive qualified bidders will be opened after evaluation of Technical Bids in the presence of bidders / their representative (who may like to attend) whereas the “Financial Bids” of technically non responsive bidders shall be returned unopened to the respective contractors.
8. The bid securities shall be in shape of call deposit in favor of the **Assistant Director (Senior) LG&RDD Headquarter Tank**
9. Matters related to the failure to submit Bid Security and Additional Security shall be dealt with in accordance with KPPRA Notification No. S.R.O. (29)/Vol:1-40/2025-26 dated 29th October, 2025 and matters pertaining to additional security shall be in accordance with Notification No. S.R.O. (14)/Vol: 1-24/2021-22 dated 10th May, 2022.
10. The call deposits i.e. Bid Security along with (Additional Security if any), for the work/ contract must be prepared after publishing of NIT, before closing time of the Electronic bid.
11. The last time and date for online clarification is up-to 05:00 PM on 21-01-2026.
12. In case of tie/draw amongst the responsive bidders, the bid may be decided through free toss which shall be considered as final.
13. The Eligible bidder must have the relevant codes for the above mentioned works as per Pakistan Engineering Council (PEC).
14. Any Electronic Bidder who provide false, or materially inaccurate or incomplete or do not send information in hard form will be disqualified as per KPPRA Act Section 29(1) read with KPPRA Rule (43). Furthermore the procuring Entity/Executing Agency will recommend and sent cases for debarring/blacklisting and will

initiate/ take action in light of approved procedure/ mechanism as per KPPRA Act Section 29(2) read with KPPRA Rule (44).

15. Bids will remain valid for **120 days** from the closing date of bids.
16. All applicable taxes shall be recovered in accordance with the directives of the government.
17. Prospective bidders who wish to participate in the tendering process must register themselves on EPADS in order to obtain a unique username and password.
18. The PEC and KPRA registration (Active tax payer) must be valid for current financial year.
19. The Tender will also be available at KPPRA website (www.kppra.gov.pk)
20. All material testing and all sorts of tests will be performed by contractor on the demand of the procuring entity.
21. The Procuring Entity may reject all bids or proposals at any time prior to the acceptance of bids or proposals in light of KPPRA Rule No.47
22. Any addition made in the terms of & conditions in NIT advertised shall be implemented as per KPPRA Act & Rules.
