### TERMS AND CONDITIONS:

1. In accordance with the directions issued by the Provincial Government vide AO(Planning)/LCB/2-1/General File/2025 dated 14.4.2025, all the process will be carried out through Government of Khyber Pakhtunkhwa E-PAK Acquisition and Disposal System (EPADS) website from the date of advertisement in newspapers.
2. As per Clause 37(A) of KPPRA Rules, all bidders must be got registered with Khyber Pakhtunkhwa Revenue Authority for the year 2025-26.
3. All bids must be accompanied by a bid security in shape of call deposit equal to 2% of the estimated cost in the name of TMO, TMA Lachi call deposit of scheduled banks shall be acceptance.
4. Sealed bids CDRs must be sent through Registered Mail/Couriers Services.
5. The tender shall be processed according to "Above/below system" based on the Market Rate System 2025.
6. The contractors quoting their bids up to a limit of 10% below Engineer estimate shall submit bid security @ 2% only of Engineering Estimate.
7. The contractors quoting their bids more than 10% below up to 20% below on Engineers Estimate shall submit along with their bids 8% Additional Security of Engineers Estimated cost in addition to 2% bid security, if the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favor of Government and the second lowest bidder and so on will be considered accordingly.
8. Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineers Estimated cost equal to the differential amount of submitted bid and Engineers Estimate along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and /or required amount of additional security, then the said bid shall be considered as non-responsive. All the securities submitted along with such non-responsive bid shall be forfeited in favor of Government and the 2<sup>nd</sup> lowest bidder and so on will be considered accordingly.
9. In case detailed rate analysis submitted with the bids is, in view of the procuring entity, not convincing the head of Procuring Entity may declare such bid as non-responsive without forfeiture of bid securities and record reasons thereof.
10. The procuring entity may offer the contract to next lowest bidder after due diligence in the context of financial difference between such two bids or may advertise procurement opportunity afresh.
11. Work order will be issued on the availability of funds.
12. Any addition made in term and conditions in the NIT advertised in the newspaper will be implemented as per KPPRA Rules
13. If the evaluated electronic bid costs of two or more bidders are equal, then the successful bidder will be declared through open draw.
14. All Federal and provincial Taxes including stamp duty and other taxes will be recoverable as per directives of the government issued from time to time.
