3. Bid Security shall be submitted in the shape of a Call Deposit Receipt (CDR) equal to 2% of the estimated cost in favour of the undersigned, along with applicable stamp duty.
4. Bidders quoting below Engineer’s Estimate shall submit additional bid security as per KPPRA Rules.
5. The bid must remain valid for 90 days from the date of opening.
6. Bidders must upload scanned copies of all mandatory documents with the online bid.
7. Original bid security and documents duly signed shall reach this office through registered courier before closing time.
8. Late, incomplete, or conditional bids shall be rejected.
9. The competent authority reserves the right to accept or reject any or all bids under Rule 47 of KPPRA Rules, 2014.
