

TERMS AND CONDITIONS:

- Bidding documents can be downloaded from the official EPADS website i.e (eprocure.gov.pk) after publication in the National Dailies and KPPRA's website.
- As per Clause 37(A) of KPPRA Rules, all bidders must be registered with Khyber Pakhtunkhwa Revenue Authority.
- The bid documents along with original bid securities and detail rate analysis (If applicable) complete in all respect must be delivered through courier to the office of TMA Gumbat before closing time of bid.
- The bidder shall submit their bids in sealed envelope within due time and date with requisite mandatory documents i.e Bid Security. Additional Security.
- The tender shall be processed according to " Above/below system" based on the Market Rate System 2025.
- The contractors quoting their bids up to a limit of 10% below Engineer estimate shall submit bid security @ 2% only of Engineering Estimate.
- The contractors quoting their bids more than 10% below upto 20% below on Engineers Estimate shall submit along with their bids 8% Additional Security of Engineers Estimated cost in addition to 2% bid security, if the bid is not accompanied with the required amount of additional security, then it will be considered as non-responsive and the 2% bid security shall be forfeited in favor of Government and the second lowest bidder and so on will be considered accordingly.
- Similarly, a contractor quoting bid more than 20% below shall submit with his bid an additional security on Engineers Estimated cost equal to the differential amount of submitted bid and Engineers Estimate along with detailed rate analysis. In case of more than 20% below bids, if the bid is not accompanied by the detailed rate analysis and /or required amount of additional security, then the said bid shall be considered as non-responsive and debar the bidder for the period of 01 year. All the securities submitted along with such non-responsive bid shall be forfeited in favor of Government and the 2nd lowest bidder and so on will be considered accordingly.
- In case detailed rate analysis submitted with the bids is, in view of the procuring entity, not convincing the head of Procuring Entity may declare such bid as non-responsive without forfeiture of bid securities and record reasons thereof
- The original bid security and additional security instruments of all bidders until signing of the contract with the be evaluated bidder of till the bid validity period whichever is earlier.
- Work order will be issued on the availability of funds.
- Any addition made in term and conditions in the NIT advertised in the newspaper will be implemented as per KPPF Rules
- If the evaluated electronic bid costs of two or more bidders are equal then the successful bidder will be declared through open draw.
- All Federal and provincial duties / stamp duty and taxes including sales tax will be recoverable as per directives of government issued from time to time.
