1. Bidders must comply with all mandatory requirements stipulated in the Bid Solicitation Documents and Instructions to Bidders, which are available for download at <https://kp.eprocure.gov.pk/>
2. All bids must be accompanied by tender form fee @ 0.03%, stamp duty and bid Security @ 2% of the engineer's estimate along with Additional security, if applicable as per **KPPRA S.R.O. (14)/Vol: 1-24/2021-22** , in original in the name of **Executive Engineer Lower C&W Division Kurram**.
3. Bid and additional securities instrument shall be submitted in hard to the office of the undersigned before submission deadline and their complete details along with their scanned copies in the required format must be submitted electronically with the bid on the EPAD's system.
4. Incomplete bids, unsealed bids or those received after the closing time, will not be entertained.
5. Representatives of the firm must submit an authority letter on the firm's letter pad, duly signed and stamped by the owner of the firm or the bids will not be entertained.
6. Bidders must quote their rates electronically as "**ABOVE/BELOW/AT PAR**" for the priced BOQ/Engineer's Estimate based on the MRS applicable.
7. In case of abnormally low bids where the bid is supported by rate analysis is not found convincing, the procuring entity may forfeit their bid security.
8. Bids will be valid for a period of ninety (90) days.
9. Joint Venture (JV) is not allowed.
10. Incase evaluated bids of two or more than two bidders are the same then the successful bid will be declared through open draw/toss.
11. Any condition/instruction not specified herein shall be governed by the prevailing rules of KPPRA, as issued and amended from time to time, and shall be observed during the procurement process.
12. For clarification of any ambiguity regarding the bidding process, bidders may visit the office of the undersigned on working days during working hours.
13. The competent authority reserves the right to reject any or all the bids assigning cogent reasons.
