- Bid documents including instruction to Bidders can be downloaded up to one day prior to the opening date from C&W from the official EPADS website, C&W website [www.cwd.gkp.pk](http://www.cwd.gkp.pk) as well as KPPRA website before the submission time.
- Bid Security 2% of the Estimated Cost in the Shape of Call Deposit (in Original) from any Schedule Bank shall be kept sealed in the financial Proposal shall in addition place an affidavit in the Technical Proposal. It is further added that original Stamp Paper duly attested by the Oath Commissioner i.e. List of Staff, List of Machinery, Non-Black-Listing / Litigation & Undertaking Certificate are enclosed in Technical Brochures.
- A copy of Technical Proposal in the required format is mandatory and to be uploaded as a part of E-PADS before submitting financial bids.
- Scanned copy of bid security shall be submitted electronically along with Technical bid on E-PADS system.
- Bids must be accompanied by a non-refundable Tender Fee @ 0.03% of the Engineer's Estimate, in the shape of CDR.
- All the bidders are required to be registered with Khyber Pakhtunkhwa Revenue Authority, Established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works consulting and non-consulting service as listed in schedule-II of Act bid.
- A complete set of criteria / bid documents should be obtained by an interested eligible bidder on submission of written application from the office of the undersigned on any working days before closing date on 14-01-2026 i.e payment of Rs. 4000 (Non refundable) otherwise his bid will not be entertained.
- The bidders should submit their bid through EPADS as per KPPRA Notification No. S.R.O. (14)/Vol: 1-24/2021-22 Dated 10/05/2022.
- Technical bids (sealed) in separate envelopes addressed to Executive Engineer Highway Division-I Peshawar should be submitted till closing date.



**INSTRUCTION TO BIDDERS (ITB)**

- Technical Proposal should be accompanied with the following:
- 1 Bidder shall submit an affidavit that Sealed Envelopes submitted along-with Technical proposal contains 2% Earnest Money.
  - 2 The bidders should submit their E-bids as per KPPRA Notification No. S.R.O. (14)/Vol: 1-24/2021-22 Dated 10/05/2022.
  - 3 Copies of valid registration with PEC, FBR and KPRA – Active Tax Payer
  - 4 Copy of valid Enlistment Certificate of C&WD for the Current Year
  - 5 National Identity Card (CNIC photocopy)
  - 6 Form H in case of Company / Firm.
  - 7 Detail of similar nature and other general works, in hands and completed during last five years supported by work orders and completion certificates duly attested from Executing Agencies concerned.
  - 8 Machinery (Tools, Plants & Equipment etc.) supported with the purchase documents as evidence of ownership
  - 9 Particular of technical Staff/engineers along with updated CVs and their agreement (for the current year) on stamp paper with the firm together with their qualification. Affidavit to the effect that the said personnel or their equivalent shall be made available for the job should also be given along with their registration number of PEC and contact numbers.
  - 10 Financial soundness supported by annual audit reports for the current year.
  - 11 Tax Return Certificate for the current year.
  - 12 Any other document to support the technical bid.
  - 13 Evaluation of Technical Proposal will be carried out with pass/ fail threshold in passing all the field including PEC registration in relevant code, Enlistment with C&W in relevant code, Tax payer proof, relevant experience in past five years, performance, technical personnel, required equipment, financial status, auditors reports, managerial capabilities, litigation status etc. Evaluation criteria in this regard can be obtained from office of the undersigned on any working day in office hours or can be downloaded from the official website of C&WD.
  - 14 All the bidding will be through E-PADS system. Technical Bid should in sealed envelope clearly marked: "Technical bid" addressed to the Executive Engineer Highway Division-I Peshawar and shall be submitted through Pakistan Post/UMS/Courier before closing time.
  - 15 The bidders are required to quote their rates (electronically) "ABOVE/BELOW/AT PAR" for both priced BOQ/Engineer Estimate based on MRS-applicable and NSI as well. Only two digits after the decimal point shall be considered for evaluation purpose.
  - 16 The successful bidder shall be subjected to all admissible taxes including Stamp duty, service charges, sales tax and any other at prevailing rate.
  - 17 Financial Bid shall be filled online. Complete bid must reach this office on or before the fix date and time.
  - 18 Time allowed for the completion of the work as specified in the NIT shall start from the issuance of work order.
  - 19 Electronic Bid validity period is 90-days.
  - 20 Successful Bidders should sign the Agreement with C&WD within (28) days after issuance of letter acceptance.
  - 21 Call deposit and Bank guarantee of scheduled banks shall be acceptable.
  - 22 If the evaluated electronic bid cost of two or more than two bidders are equal than the successful bid will be declared through open draw.
  - 23 Technical Bids will be opened in office of the Executive Engineer Highway Division-I Peshawar after 30 minutes of closing time in the presence of bidders/their representative who choose to be present.
  - 24 Financial bids (Electronic bids) will be opened in office of the Executive Engineer Highway Division-I Peshawar on later date which will be communicated to technically qualified bidders only.
  - 25 The procuring entity has the authority to reject any bid or all the bids assigning cogent reason.
  - 26 Bid security of the first, second and third lowest bidders for the specific work will be retained by the Authority till the approval of bids.
  - 27 All the information in documents provided by the bidders must be based on facts beyond any doubt. Any misrepresentation, false statement or fake document found in the proposal at any stage, would lead to debarment/blacklisting of the firm. The matter may also be reported to the PEC for cancellation of registration/license of the respective firm.
  - 28 Pre bid will be held on 12-01-2026 at 2.30 PM in the office of the undersigned.
  - 29 All bidders are required to be registered with the Khyber Pakhtunkhwa Revenue Authority, established under the Khyber Pakhtunkhwa Finance Act, 2013 (Khyber Pakhtunkhwa Act No. XXI of 2013), for works, consulting and non-consulting services as listed in Schedule-II of the Act ibid.
