NOTICE INVITING TENDER (EPADS)

Project Director "Establishment of Special Game Reserve in D.I.Khan" invites Bids from reputed firms/suppliers, duly registered for Income Tax and Sales Tax, for supply of Cow Dung (Organic / Natural Manure) for dumping in proposed Rakh Sheikh Buddin Game Reserve, in accordance with KPPRA Procurement Rules-2014 on **Single Stage Single Envelope Procedure** through EPADS for the supply of cow dung under the project titled: "Establishment of Special Game Reserve in D.I. Khan".

TERMS & CONDITIONS:

1. The Bidding documents can be downloaded from the official EPADS website i.e. (<https://kp.eprocure.gov.pk/>) after publishing of NIT. The Bid Soliciting Documents shall be filled neatly and a clear readable scan copy of the same shall be uploaded at the time of bid submission through EPADS.
 2. The firms / suppliers who wish to participate in the bidding process shall register themselves at the EPADS portal.
 3. The bidders are required to fill online bids and upload the scan copies of the bid documents along with original tender form, original bid securities i.e. 5% bid security.
 4. The bids security shall be in the shape of CDR in favor of Project Director "Establishment of Special Game Reserve" from the any scheduled bank of Pakistan.
 5. Cutting and overwriting in the bidding documents (including tender form, etc.) shall not be acceptable.
 6. The form of Bid and Bid Security shall be complete in all respects and the bidders shall submit the same in "Original" along with other relevant documents in sealed envelope to the office of Project Director "Establishment of Special Game Reserve in D.I.Khan", North Circular Road, D.I.Khan City through registered courier before the closing date and time for submission of bids.
 7. The bid security Call Deposit Receipts (CDRs) shall be prepared after publication of the NIT and before the closing date and time for submission of electronic bids.
 8. **Interested firms/contractors must provide the following information with their application/Bidding documents:**
 - i. Photocopy of National Identity Card
 - ii. Active registration status with the relevant tax authorities.
 - iii. Affidavit of Non-involvement in any court case with the department.
 - iv. Any other documents, which the firms may consider necessary.
 - v. Application must be signed by authorized person of the firm with official stamp
9. The suppliers/representative of suppliers are invited to be present at the time of opening of electronic bids at the Office of the Project Director "Establishment of Special Game Reserve

in D.I.Khan", North Circular Road D.I. Khan City.

10. Tender shall be processed according to aggregate amount quoted.
11. Any Electronic Bidder who provides false, materially inaccurate, or incomplete information — will be disqualified under KPPRA Act Section 29(1) and Rule 43. Additionally, the Procuring Entity/Executing Agency will recommend the case for debarring/blacklisting and initiate action as per KPPRA Act Section 29(2) and Rule 44.
12. Bids securities of 1st, 2nd 3rd lowest bidders will be retained by the procuring entity till approval of tenders.
13. Bidders are at liberty to seek any clarification or further information from the office of the undersigned or through EPADS portal during office hours until one day before the closing date for submission of electronic bids.
14. Work/Supply Order will be issued subject to the availability of funds and payments thereafter.
15. All applicable taxes will be deducted and shall be recoverable as per the directives of the government and in accordance with the rules and regulations in practice.
16. The rates offered for Supply of Cow Dung will be valid up to 30/06/2026.
17. Supply of Cow Dung shall be made to the Rakh Sheikh Buddin Game Reserve on site identified by the Concerned Range Wildlife Officer / Wildlife Staff.
18. Proper pictorial evidence and GPS points of each dumping site shall be recorded by the Contractor / Supplier and be provided to the Physical Verification Committee.
19. After the award of contract, the successful bidder shall seek approval of Physical Verification Committee by provision of samples before supply.
20. The Procuring Entity may reject bids at any time prior to its approval as per KPPRA Rules 2014.
21. Any addition made in the terms and conditions in NIT advertised shall be implemented in accordance with KPPRA Rules 2014.
