2. Interested bidders shall submit bid(s) by uploading scanned copy of bid(s) on EPADS on or before **January 22, 2026 till 11:00 AM (PST)**. The bidders shall upload all relevant/mandatory document on EPADS.
3. The Scanned copy of the bid security must be attached with Bids on EPADS. Bids without Bid Security on EPADS will not be entertained.
4. Original CDR/ Bid Security must be submitted to the office of the Treasurer/Procurement Section University of Peshawar on or before **22.01.2026 at 11:00 AM (PST)**. If the original Bid Security/CDR does not reach the aforementioned office by the closing date & time, the bid will be rejected.
5. Electronic Bids shall be opened on the **same day at 11:30 AM (PST)**
6. Income Tax, Stamp Duty, Professional Tax and KPRA or any other Government tax will be deducted as per rules.
7. Procurement will be carried out as per Act and Rules of Khyber Pakhtunkhwa Public Procurement Regulatory Authority (KP-PPRA).
8. Registration with KPRA is mandatory, wherever applicable.
9. The Bid accompanied by Pay Order (PO) shall be rejected.
10. Bids received by hand/Post/Courier, E-mail, or Fax shall NOT be accepted.
